According to Ayuba, the printer confessed to having been in currency counterfeiting over three years and named those he supplied fake currencies for circulation.

"His confession led to the arrest of the couple, who are partners in the crime," she added.

She further stated that the confessions of the couple led to the arrest of the former soldier who was allegedly found to be in possession of some suspected counterfeit local and foreign currencies when his house was searched.

According to her, efforts are being intensified to apprehend members of fleeing syndicate.

wo persons were on Friday killed in a road accident at Azia junction Ihiala, by Owerri-Ihiala Expressway, Anambra State.

City Round learnt that the lone accident involving an unidentified commercial driver of a Mercedes truck with registration number: XD131NSHU343RE occurred at about 9:30 am.

An eyewitness said the driver, who was at top speed, lost control and rammed the truck into a big gutter by the roadside, leading to the crash.

Confirming the accident, the acting Sector Public Education Officer of the Federal Road Safety Corps in the state, Margaret Onabe, said two people, comprising two male adults, were involved in the crash.

Onabe said, "The cause of the crash was attributed to speeding and loss of control. According to eyewitnesses, the driver was speeding, lost control, and rammed into a big gutter by the roadside.

Two male adults (the driver and his conductor) were killed."

She noted that the dead victims were taken to Our Lady of Lourdes Hospital Mortuary, Ihiala, by good Samaritans before the arrival of the FRSC rescue team.

She also said that the FRSC rescue team removed the debris littered on the expressway, and restored normalcy in human and vehicular movement.

"The Sector Commander, Anambra State, Corps Adeoye Irelewuyi, sympathised with the family of the victims. He warned motorists to desist from speeding and drive within the safe speed limit they can control. Let's drive to stay alive; road safety is everyone's responsibility."
