The Independent National Electoral Commission (INEC) has concluded arrangements to prosecute the four ad-hoc staff who allegedly diverted six voters' registration machines to the residence of PDP chieftain, Chief Lamidi Adedibu.
Investigations at INEC office

in Ibadan, Oyo State, revealed that the prosecution was delayed due to certain logistic and documentation errors.

According to a reliable source, all the accused would soon be properly charged to court, adding that there would be no sacred cow as the law would be made to

take its cause.
Our source further stated: "We have concluded arrangements to file the necessary papers before the court and once that is done, the culprits would be made to face the court. What actually delayed their trial is that we do not want to go to court without putting our acts together. That, we have done."

The source revealed that proceedings on the matter would commence on or before the end of next month.

Already, the commission has charged an ad hoc staff, Mr. Lateef Lawal to the Iyaganku Magistrate's Court, Ibadan, for alleged diversion of voters' registration

machines to a wrong place.

The charge filed against him reads: "That you, Lateef Lawal, together with others now at large, on 22 January, 2007, between 2 and 3 p.m. at Kereke Compound, Arooye area, Ibadan, in the Ibadan Magisterial District, conspired with others to carry out spired with others to carry out registration of voters at a wrong centre and thereby committed an offence contrary to and punishable under Section 12 (1) of the Electoral Act, Oyo State of Nigeria, 2006."

After granting him bail in the sum of N50, 000 with two sureties, the presiding magistrate, Quadri, adjourned the case till 7 March, 2007.

Although, policemen at the Special Anti-Robbery Section (SARS) have denied that Rasaki died in their custody, the family alleged that the deceased was tortured to death in the SARS cell after he was arrested by the

policemen.

Association of Nigeria (RTEAN), Chief Sunday Ogunyade, a.k.á. Ajeti, was the one who told the police to arrest the deceased who was sent by his master, Alhaji Adigun Kareem, to inspect a plot of land at Iloro, Agege on 8 January, 2007.

The plot of land is the subject of a dispute between Chief Ogunyade and other land owners in the area. They include Alhaji In the area. They include Alhaji Isiaka Adekunle of Harp and Timbrel, Alhaji Adigun Kareem and Chief K.F. Olabinran. It was gathered that Chief Ogunyade had been threatening

land owners in the area and using the police to arrest and detain anybody found on the vast land.

Narrating the circumstances that led to the death of Rasaki, his employer, Alhaji Adigun Kareem, said he sent him on the fateful day (8 January, 2007) to inspect the construction going on on his plot of land at Iloro, Agege.

I asked him (Rasaki) to take an Okada (commercial motor-cycle) to inspect what was going on on my plot of land at Iloro on 8 January, 2007. "After waiting for more than five hours and I didn't see him, I

went to the land site to know what was happening. On getting there, I met Chief Ogunyade, 12 mobile policemen and more than 25 thugs at the site. The mobile cops were led by a police officer, Hassan Emmanuel, while the others were led by another officer, Malam Gamji Abana, OC SARS.

I couldn't ask any question because I was warned by people around that I would be arrested and beaten if I dare talk to the

policemen there.
"They also told me that the boy I sent, Rasaki, and his friend, Sunday Asiko, have been arrested by the policemen.

I went back and got in touch with Rasaki's sister, Iyabode Obadara, who went to the Alagolo Awosoga Police Station, but the DPO told her that Taiwo was not detained there.

"We went to all the police stations around Lagos to search for him (Rasaki) but we couldn't find him.

"On the third day, policemen from SARS, led by one Charlie came to my house at 1/3, Ogunsheye Road, Ikola, near iasa Command, around 3 a.m. I thought they were robbers, so,

I did not open my door.
"Around 5 a.m., they forced the door open, arrested me and took me to SARS office. "At SARS, they accused me

of attempting to sell a plot of land belonging to Deputy Commissioner of Police, Mr. Olayinka Balogun, the officer in charge at the SCID, an allegation I denied.

"Since then, every effort to locate Rasaki proved abortive until we saw Sunday Asiko (Rasaki's friend) where he was receiving treatment. He told us that he and the deceased were detained at the SARS and tortured, adding that in the process,
