"My wife was in the habit of giving me sex once and giving those outside five times. How can I, the owner of something, be deprived of my property in preference for outsiders?" the accused asked the Chief Magistrate trying him.

The accused, who was not represented by a lawyer on a two-count charge of premeditated murder, also told the court that his late wife was in the habit of bringing robbers to rob him each time he had money

"You people are shouting now because I killed Unwana. If you were witnesses to what I was passing through in the hands of

that woman, you will pity me. I have been working for the past 10 years and I have not been able to build a house or even buy a plot of land. Each time I have money, that woman, Unwana will bring robbers to attack me and collect the money," he told the court.

The Magistrate ordered that he should be remanded in prison custody till 20 June when the matter comes up again for hearing.

After the ruling, he said: "My God is in control and will justify me for eliminating that woman from my life."
