Man Murders Wife

A man identified as Anietie Owonam, has beaten his wife, Rose Utu, to death in Calabar, the Cross River State capital.

And the family of the woman are accusing the police of foul play following the release of her husband who was arrested after the incident.

Rose, who had been married to Anietie for the past ten years was said to be pregnant with their third baby when Anietie beat her to death for allegedly

Helen Utsu, elder sister to the late Rose told P.M.News in Calabar that trouble started in the morning of Sunday, 5th Au-

gust, when her sister asked Anietie, a staff of Tank Farm at the Export Free Zone, Calabar, to provide the money to enable her procure food stuff for the house and baby's needs since he had just been paid. Anietie, she said, offered to give her N5,000 which Rose said was inadequate. "Grace, my younger sister who

Rose rejected the sum offered by Anietie, the man abused her and

said that God should punish her and the baby inside her womb." This, she said, prompted Rose to tell Anietie that he "should have abused only herself and not the baby in the stomach since the child does not know anything." This eventually led to a fight

between the couple.

Anietie allegedly hit her in the chest and head which made her to collapse and become unconscious. Neighbours who came to the scene revived the woman but she was "very weak throughout that Sunday and could not even eat and Anietie did not take her to hospital. In the night when she became too sick, she called on Grace to rub her anointing oil on her fore head. Immediately the oil was robbed on her she lapsed

Anietie, Heline said, did not do anything until Monday morning when he went to see Regina Abuo, a friend to Rose who resides close by and informed her that "he does not know what is happening to Rose". It was when Regina came that she appealed to one of the neigbours who owns a car to assist them take the woman to hospital.
