# Lagos Condemns Saula's Murder •Appeals For Calm

The Lagos State Government has condemned the gruesome murder of the state Chairman of the National Union of Road Transport Workers (NURTW), Chief Saka Saula, and appealed for calm.

Commissioner for Transportation, Prof. Bamidele Badejo conveyed the sympathy of the state government to the family of the deceased, while describing the murder as a callous act.

He described Saula's murder as an ugly development, a colossal loss and an immeasurable setback for the NURTW which, he said, witnessed monumental growth under the leadership of Saula.

The commissioner appealed to the NURTW executive and members to maintain peace and shun violence.

He said the state government would liaise with the various security organisations to unravel the circumstances leading to the gruesome murder and unveil the perpetrators of the heinous act.

Badejo assured that justice would not only be done but that "it shall be seen to have been

Popular transporter and chairman of the Caretaker Committee of the Lagos chapter of the National Union of Road Transport Workers (NURTW), Alhaji Saka Saula, has been assassinated.

He was killed around 9.30 p.m. yesterday at his Adeboun Street, Iyana Inaia residence by four

yesterday at his Adeboun Street, Iyana Ipaja residence, by four suspected assassins, who came in a Honda Accord car.

Alhaji Saka, 45, was reportedly attacked with guns by his killers who lured him out through three commercial motorcyclists. The commercial motorcyclists, it was gathered, were dis-

He was shot several times by his attackers, who pursued him until he fell into a gutter.

His fall was allegedly aided by the Jalamia (kaftan) he was wear-

But the general secretary of NURTW, Chief Stephen Falusi, denied this account, saying the assassins ambushed


# ...Death Sparks Riots In Oshodi, Iyana Ipaia

# **The Man** Saka Saula

The slain Chairman of the Lagos State branch of the National Union of Road Transport Workers (NURTW), Alhaji Saka Saula, was born in Gbagura, Agboola Odofin compound in Abeokuta, Ogun

He started as a bus conductor in Lagos in 1976 and later became a driver

According to Saula in an interview, "I learnt the rudiments of trade from Thomas Ashodumeto, a man who is still a driver...

He said they used to ply Palmgrove, Ladilak and Abule-Oja in Somolu and Bariga areas of Lagos. It was from here that he ioined the NURTW and rose to become supervisor of motor parks, the union's branch PRO and later, the vice chairman of the union (Alimosho Branch 'A').

He rose to the position of chairman of the caretaker committee of the union and the substantive chairman in controversial circumstances that led to series of violence in some motor parks following bloody clashes between his supporters and thugs in the opposing camps.

He had four wives and several children, five of whom are said to be attending schools overseas.

He was in his late 40s when he was killed yesterday.

Alhaji Saka as he came out of his jeep after returning home

Chief Falusi, who said the authentic account of how the NURTW boss met his death came from his wife, Alhaja Lateef Saula, disclosed that the assassins did not give the deceased any chance at all as they pumped hot lead into him.

Alhaja Lateefat and other members of the household were said to have rushed him to the Ikeja General Hospital in a Peugeot 206 car, where he was later confirmed dead.

Following the death of the transporter, P.M. News gathered that one of his aides has been arrested by the police to aid their

investigation. The residence of the deceased was a beehive of activities this morning as policemen commenced investigation into the

The late Alhaji Saka Saula is survived by about four wives and many children, some of who

are schooling abroad. He was described as a generous man who tried to help any-

body he came across.

The deceased had also often been linked to riots and civil dis-

turbances in the state.

In April 2000, Saula and 19 others were arraigned before an Ikeja Magistrate's Court for causing a breach of peace within the

court premises. Violence erupted in January last year at Iyana Ipaja and spread to Dopemu, Pen Cinema in Agege

The remains of the slain chairman of National Union of Road Transport Workers (NURTW), Alhaji Saka Saula will be buried today according to Muslim rites.

Steven Falusi, the state secretary of the NURTW told P.M. News this morning that the executive members of the union have discussed with the family and they have agreed to bury him today.

to the streets, turning back com-muter buses and dislodging passengers from the buses

Recalcitrant bus drivers were whipped and their vehicles damaged by the protesters who blamed the death of Alhaji Saka on the infighting within the Lagos chapter of NURTW.

Markets, shops and stalls were deserted as a result of the protest while area boys capitalised on the situation to rob stranded passengers

One of the unlucky passengers, Mrs. Lola Aofolaju, who lost her valuables to some hoodlums in Alimosho recounts her ordeal: "I did not know of any crisis until I got to this bus stop around 6.15 a.m. The only thing I noticed was that people started running back from Iŷana Ipaja and before I could escape, some boys swooped on me, beat me up and made away with my phone,

wristwatch and bag."

Mrs. -Aofolaju, who runs a boutique in Ojuelegba, claimed that her attackers made away

to commiserate with the family. At his residence, wailing rent the air as friends, relatives and

sympathisers passed by the blood stained staircase leading to his personal residence where he was killed.

A leader of the group who spoke under condition of anonymity told *P.M.News* that the murder of their chairman was a

big loss to the union.
"When you lose somebody of Governor (Saka)'s status, it is a big loss. It is sad. But we have taken it in good faith. We are a peace-loving set of people. We are serious-minded, and we have learned minds among us," he retorted.

Apart from the motor park, commercial transport activities were virtually paralysed in other parts of Ikeja.
