P.M.News gathered this morning that the soldier along with two of his colleagues, Lawrence Akpa and Femi, were said to have gone to the bar situated along Marian Road for a drink on Sunday evening and were there until early Monday when the incident that led to his murder

A Chaplain with the Brigade attached to the Catholic Church, Lance Corporal Imoke, told P.M. News that soldiers have been warned against late nights in Calabar whether for beer drinking okada business but such warnings have always fallen on deaf ears "perhaps because it is

A source said Lawrence and Femi, who had just returned from peace keeping mission in Liberia, went to the bar "to celebrate their went to the bar "to celebrate their successful return. They were there from early Sunday evening to early Monday morning. While they were drinking, one of the girls brought by the soldiers went to ease herself and one of the boys grabbed her chair but the soldiers asked him to keep the chair as their girl was keep the chair as their girl was sitting on it. The boy asked them if they brought the chairs from their homes.

This remark was said to have infuriated the soldiers who slapped the boy and his friends decided to intervene. This led to a free-for-all In the ensuing confusion, a team of policemen on patrol came in and arrested the soldiers who refused to go with the police but the police insisted and dragged the drunken

Idowu, who sat in a separate chair, did not join in the fray until one of the attendants alerted the boys that he too was a soldier, said

"When the boys knew that Idowu was also a soldier, they slapped him. When he tried to put up a fight, he was stabbed by the boys and left to bleed to death," the source said.

He said the body was left there until late Monday morning when he was discovered and taken to the mortuary

According to the Chaplain, ance Corporal Imoke, "The police team that took Femi and Lawrence to the police station were not aware to the police station were not aware that their colleague had been killed. When the soldiers heard on Monday morning what had happened, they wanted to attack the place but I advised them not to. They obeyed me as a man of Cod. They obeyed me as a man of God; Calabar people have no respect and love for soldiers. An attack in that place would have led to more bloodshed."
