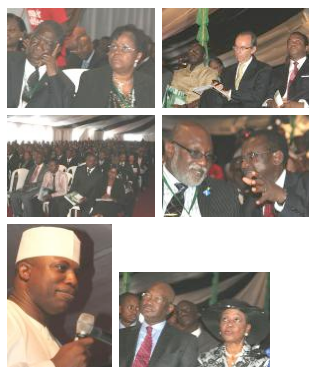

## Lady Kills Brother For Stealing Meat

**The police in Lagos on Wednesday arrested a 24-year-old lady for allegedly beating her nine-year old stepbrother to death at Ilupeju area of the state.**

The suspect, Janet James, a househelp to an Indian couple, was alleged to have beaten the victim, identified as Saviour Effiong, to death after accusing him of stealing some pieces of meat.

Parading the suspect, the police spokesman, Mr. Frank Mba, said the Akwa-Ibom State-born suspect dumped the remains of the deceased at a flower lounge of a nearby building to ward off suspicion from people around her 15, Adeola Adeleye, Ilupeju residence.

He said that the suspect was earlier in the year arrested by the police at Ilupeju, when she was accused of maltreating the deceased.

Mba disclosed that a security man with a defunct insurance company discovered the lifeless body of the boy where it was dumped by the suspect.

According to him, preliminary investigations by the police led to the discovery that the deceased was the same boy that was brought to the station some months back for maltreatment.

He said that the suspect confessed having beaten the deceased to death after initially lying that she had taken him to church for prayers.

The police spokesman added that the suspect had initially signed an undertaking that she would return the boy to the village.

Mba said that after the conclusion of investigations, the suspect would be transferred to the homicide section of the state Police Command.

Also speaking with newsmen, the suspect confessed that she beat the deceased to death with a wooden pestle.

"Please, I beg for forgiveness, I have regretted my action.

"I only thought of beating the boy to punish him, I did not intend to kill him for stealing meat from the pot," she said.

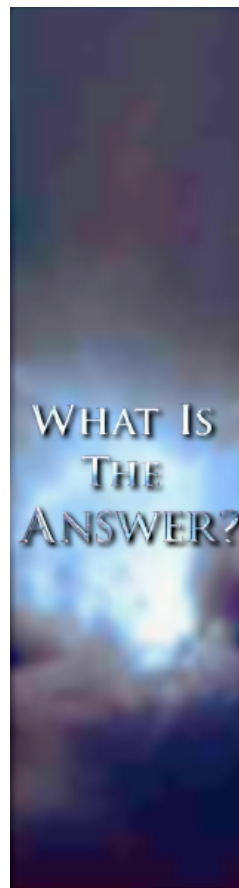

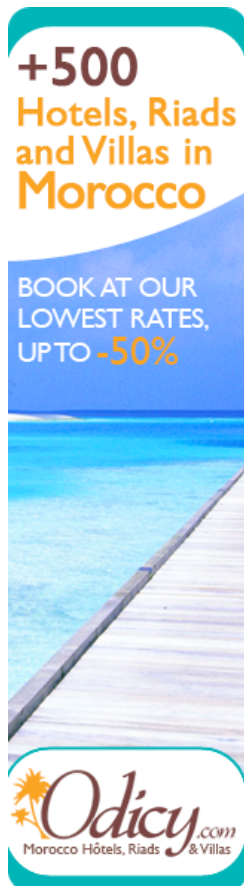
