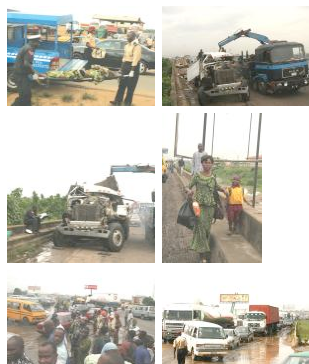

Acid Bath Woman Dies

A 45-year-old woman, Mrs. Victoria Agoro, who was bathed with acid in Ikorodu area of Lagos State on 6 October, this year, allegedly by her estranged son-in-law, Chijee Anyalibechi, a.k.a Prince, has died as a result of the burns she suffered from the attack .

P.M.NEWS gathered that Mrs. Agoro died at about 6p.m. yesterday at the Lagos State Teaching Hospital (LASUTH) where she had been on admission since the attack.

It was reported that Mrs. Agoro was sleeping at her residence in Igbocho when Anyalibechi, her son-in-law, bathed her with acid.

Luck ran out on him when he tried to escape after the attack. He was apprehended and handed over to the police.

The assailant, it was gathered, sustained serious injuries from the mob attack and was admitted at the Ikorodu General Hospital.

Mrs. Agoro's daughter, Abiodun, an undergraduate of the University of Abuja, told *P.M.NEWS* then that she regretted marrying Anyalibechi.

Abiodun and Chijee were into a courtship that lasted a few months before they tied the knot in June 2008.

Shortly after the marriage, Abiodun discovered that Anyalibechi, 38, was not a lawyer that he claimed to be, but he was said to be into alleged shady deals.

"I complained severally on his sleazy ways, but he always lied each time I challenged him," Abiodun said.

The UniAbuja undergraduate said that in July, this year, when Anyalibechi could no longer cover up his tracks, he accused her of infidelity and said he was no longer interested in the relationship.

"I denied the charge but he was bent on ending our union, so he took me down to my mom's place in Ikorodu and dumped me there. Family members tried to intervene but he stood his ground," Abiodun disclosed.

Thereafter, he left his base in Abuja and relocated to a friend's residence in Ikorodu very close to that of his in-laws.

"He must have planned to pour the acid on me but he didn't find me at home that day. He must have turned to my mom instead, because he didn't want the acid to waste.

"I don't know what our offence is but I believe I was his target. May be because I found out his secrets.

"He claimed to be what he wasn't. He is fraudulent and devilish. I later found out that the family members he brought to my parents when we were to be married were not his real relatives. He actually hired them," Abiodun narrated.

However, *P.M.NEWS* could not ascertain the state of health of Abiodun's sister, Aminat, who was also affected by the acid attack.

A source at the State Criminal Investigation Department (SCID), Panti, Yaba, Lagos, where investigation into the incident has been ongoing, informed *P.M.NEWS* that Anyalibechi was yet to be charged to court because he was still receiving treatment at the hospital.

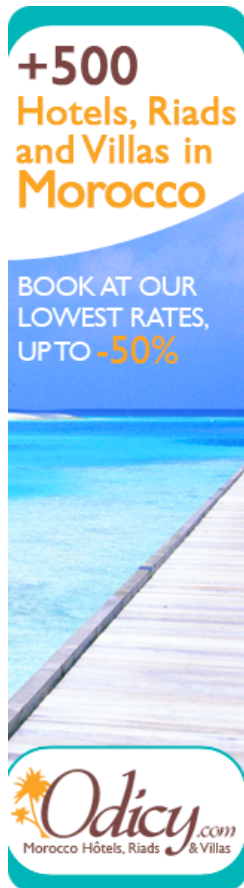
