My Ex-Wife Drove Me Into Human Parts Trade —Herbalist

A native doctor in Igando, Ojumu Okanlawon, who allegedly slaughtered a house wife and cut her into pieces, has confessed that his former wife drove him into human parts trade.

Ojumu, who is now in the police net at State Criminal Investigation Department, Panti, Yaba, Lagos, said that he was derided by his wife and friends because he has no money and needed to sell human parts to earn big money to prove a point to them.

He said that he was a welder when he married his estranged wife and she divorced him because he had no money. He also said that his friends saw him as a poor man which he never liked.

He said his wife divorced him three years ago and he left his welding business and became a native doctor.

Okanlawon said that it was when he became a herbalist that a friend introduced him into the business of selling human parts.

"I was homeless and I went and lived with my friend Akin. The problem was too much for me until my friend introduced me into native doctor and later human parts," he revealed.

He could not say how much he has made in the business and how many people have fallen victim and who are his customers.

The 40-year-old man is now regretting his involvement in the crime and promised to turn a new leaf if he is pardoned.

Okanlawon had cut the mother of five children, Iya Okiki into pieces and packed the parts in a sack when he was arrested.

After his arrest by the police, he reportedly confessed that he sells human parts.

Ikedi Ogunlaiye, as he is popularly known in Igando, was alleged to have lured the woman into his house at 21, Ororungebebe Street, Off Oremoji Street, Igando with other accomplices and murdered her.

He later butchered her into seven pieces and hid the parts in a sack for distribution to his customers.

The dastardly act was blown open when his neighbour suspected strange movement at night when the victim was murdered. The neighbour reported the case to the landlords association.

The association confronted Okanlawon and on getting into his apartment, there were blood stains in his kitchen and toilet. The police were immediately alerted.

When the police got to his house and searched, they discovered cutlass, saw, chisels which he used to cut the woman into pieces. Also, the butchered parts were recovered in a sack.

The suspect was immediately arrested with his three accomplices two of whom were later identified as Akin and Baba Olowu Apena.

The body of the woman was later identified by her husband. Her remains have been deposited at the Isolo mortuary, while the matter has been transferred to Panti for further investigation.

The landlords association in the area where the incident happened has called on the police to do a thorough investigation on the matter and bring the culprits to book.
