Cashier Steals Company's N4.9m

Yaba Magistrate's Court in Lagos on Monday granted bail in the sum of one million naira to a cashier, Hope Nwokemodo, who allegedly stole her employer's N4.9 million.

Nwokemode (48), charged with stealing the money belonging to Ebice Hose Ltd., Sabo, however, pleaded not guilty before Magistrate Salamah Matepo.

The Prosecutor, Insp. Benson Emuerhi, told the court that the accused was in charge of depositing the firm's money in banks, but that she diverted the N4.9 million between October and December 2009.

He said that the alleged offence contravened Section 390(6) of the Criminal Code of Lagos State, and punishable seven years' with imprisonment.

The case has been adjourned till July 14 for further hearing.

In a similar development, the police in Lagos on Monday arraigned a clearing agent, Linus Obiagboso, for allegedly defrauding a businessman of N1.1 million.

Obiagboso (43) was charged with conspiring with others, still at large, to dupe one Mr. Chigozie Metu under the pretext of helping him to clear four containers of marble and electric bulbs.

The accused, however, pleaded not guilty to the fourcount charge of conspiracy, fraud, stealing and forgery before an Ebute-Metta Chief Magistrate's Court.

The Prosecutor, Insp. Eshiet Eshiet, submitted that the accused, who received the money from Metu for the clearing of the goods from the Apapa Port in Lagos, failed to

Spokesman for the Baruwa family. Akinola Davies told P.M.NEWS that Kudus went to a party at Awonaike Crescent, Surulere in company of some friends and decided to leave the party with his friends at about 11 p.m.

On their way home from the party. Kudus and his friends had an encounter with one of the area boys identified as Kunle who was riding a motorcycle.

The deceased and his friends accused the suspect of dangerous driving but he disagreed and called them

unprintable names.

This got the friends infuriated and fighting ensued during which the suspect, who is now on the run, was thoroughly beaten.

He reportedly ran home and told his brothers what happened and he and his brothers laid an ambush for Kudus.

Unknown to the deceased that danger was lurking in the air as he was returning home, his assailants, led by Kunle attacked him and stabbed him several times.

Evewitnesses who attempted to save the deceased were warned to keep off by Kunle and his group who threatened to kill them.

Policemen who arrived the scene later took Kudus to the University of Lagos Teaching Hospital (LUTH) Idi-Araba, Lagos where he died a few hours after being admitted.

The murder is currently being investigated by the police at Area 'C' Command.

Davies, however expressed disatisfaction with the way the police were handling the matter, saying the Baruwa Family has petitioned the Deputy Commissioner of Police, State Criminal Investigation Department (CID), Panti, Yaba,


