
According to him, her death was confirmed at Harvey Hospital. He described his late wife as easy-going and humble. He

r. Ganiyu Ayodeji, chairman National Union of Road Transport Workers (NURTW) LOB Unit, Ikeja chapter, Lagos State, southwest Nigeria, has been arraigned before an Ikeja Magistrate Court on a two-count charge of conspiracy and conduct likely to cause a breach of peace.

Ayodeji was alleged to have committed the offences on 14 and 15 June 2011, at about 3pm

at the Ikeja axis of the Lagos-Abeokuta Expressway.

He was alleged to have led some members of his union, who are now at large, to remove the stickers of the Road Transport Employers Association of Nigeria (RTEAN), Zone 6, Agege.

The offences according to Prosecuting Police Officer, Inspector Roman O. are punishable under Section 516 and 249 (D) of the Criminal code Cap. C17, Vol. 2, Laws of Lagos State

of Nigeria, 2003. He pleaded not guilty to the charges.

The presiding magistrate, Mrs. A. Y. Omoyele granted him bail in the sum of N20,000 with two sureties. The sureties, according to the magistrate, must present to the court evidence of three years tax payment to the Lagos State government, means of livelihood and have their address verified by the court prosecutor.

The matter has been adjourned till 18 July, 2011, for trial
