It was a sad end for Yisa Anifowose, the leader of the Odua People's Congress, OPC, at Shasha, Akowonjo, Lagos State, Southwest Nigeria, when his friend, John Taju, shot him dead while testing the efficacy of his newly acquired bullet-proof charm.

The charm could not prevent

bullets from penetrating into his body as he reportedly boasted before he was shot.

He slumped and died as a result of the injury he sustained during the shooting. His corpse has been deposited

at Igando General Hospital, *P.M.NEWS* for autopsy. The late Anifowose was mar-

ried and had six children. Anifowose, 54, popularly called Baba Kazeem, was shot in the chest by his friend and member of OPC. Taju, a oneeyed man. The suspect has been arrested.

The incident happened at the OPC tarmac, Zone 5, Orisumbare, Shasha, Lagos, the family home of the deceased.

Continued from pg. 1 A police source told PMNEWS that the robbers stormed Aden Estate, beside Abraham Adesanya Estate, Ajah, at about 1 a.m. today and attacked a businessman

and his family.

P.M.NEWS investigations revealed that while the robbers were trying to gain access into the residence of the business-man, he hid somewhere and called his friend who later called the Ajah Police Area command and their divisional. headquarters.

The anti-robbery policemen laid ambush for the robbers who ran into the ambush after their operation.

The police killed three of

them, arrested one while the other two escaped.

The arrested robber gave his name as Kazeem Alao from Ikota near Ajah. One of the dead robbers was later identified as Tunde Sanni.

It was learnt that Sanni had escaped from police custody while he was being taken for interrogation by policemen from Lagos about three months ago.

Items recovered from the robbers include one Ak-47 rifle with ammunition, one U.S-made brownie pistol with ammunition and one locally made pistol with several cartridges.

The suspect arrested has made a useful statement to the police at Ajah Police Division where he is currently being detained and undergoing inter-

The mother of the victim, Madam Tugbobo sat down on the bare fleor of the sitting room while sympathisers surrounded her

The late Yemi Tugbogbo was married and had two daughters.
Neighbours described him as an easy going gentleman who could hardly hurt a fly.

A community leader in the area, Hon. Mathew Adesanya expressed shock at the news of

Yemi's death.

He said the victim was his barber and was a well behaved gentleman who lived peacefully with his neighbours.

Adesanya prayed that God should console the bereaved

On returning to Lagos, he was invited by his friends who are members of the OPC, to their base to celebrate his newly acquired power and the purchase of a new car by one of his members.

It was while they were celebrating that Baba Kazeem asked Taju who had a locally-made gun on him to shoot him to test the efficacy of the new charm.

Taju reportedly shot Baba Kazeem and the bullet tore his chest. He died on the spot. His death threw the residents

into confusion and his friends fled the scene.

Some residents of the area quickly locked up their houses and shops and relocated from the area to avoid being arrested by the police.

Thematter was reported at the Idimu Police Station. But before the police arrived the scene, Taju had escaped.

The government should intervene and arrest those involved in his death," she cried. A brother of the deceased,

Adedeji Ajanaku, described the deceased as a courageous man. He called on the government to release his corpse to the family for burial in accordance with

mencement of proceedings in the matter, than the Prosecution team led by Dr. Alex Izinyon, a senior advocate of Nigeria, applied to withdraw a pending 2-count charge filed against Asiwaju Bola Tinubu which had been severally circulated in the media and sought to replace it with a fresh 3-count charge which are similar to those of the earlier charge but for the inclusion of a third count.
Dr. Izinyon confirmed that he

just served the amended charge on the legal team of the former Governor right there inside

the court.
Chief Wole Olanipekun, leading a legal team of 10 senior advocates of Nigeria comprising Oluwarotimi Akeredolu, Charles Edosanwa, Niyi Akintola, Dele Belgore, Prof Yemi Osibanjo, Kabiru Turaki, Ifedayo Adedipe, Deji Sashogbon, Dele Adesina and Femi Falana and other lawyers, for the defence of the former Lagos state Governor, while reacting to the application of Dr. Izinyon, told the court that the presence of Bola Tinubu in court today was as a sign of respect to the institution as he was not personally served as required by the law before his appearance.

The Presiding Chairman of the Conduct Tribunal, Hon. Danladi Yakubu Umar, complimented the former Governor for such an act, noting that since he was not personally served, he would have opted not to appear before the Tribunal.

He called on others to emulate the sterling behaviour of Tinubu who chose instead to appear and ensure that the wheel of instead ensure that the wheel of justice

is not delayed.

Olanipekun indicated that his team would not oppose the application to withdraw the earlier charge but requested that time be allowed for them to file similar preliminary objection which they had filed against the pending charge which is being

withdrawn.

Having indicated that the defence team is not opposed to the withdrawal application moved by the prosecution, the Tribunal struck out the earlier charge and replaced it with the

fresh 3-count charge.
That was as far as the matter proceeded before a legal hurdle was placed against attempts by Dr. Izinyon to get the new charge read to Bola Tinubu for his plea

to be taken. Olanipekun blatantly refused for his client to take a plea on the new charge, noting that they are challenging the jurisdiction of the Tribunal to try the former Lagos state governor. He told the court that it had to dispense with the issue of jurisdiction first

before plea can be taken.

The senior advocate told the court that the defence team is contesting the jurisdiction of the court to entertain the matter as well as the competence of the charge which they said is defec-tive and wondered how the court can compel one to take plea on a defective charge.
He specifically told the panel

members that there is no known law which empowers them to side track the former governor's right to challenge their jurisdiction, more so since he, Tinubu, had raised his objections time-ously as required by the law.

The panel members noted

that they are for fairness to both the complainant and the defendant and observed that the discussion of jurisdiction raised by Tinubu is crucial. Subsequently, the court acquiesced to the request of Wole Olanipekun to formally file their preliminary objections file their preliminary objections

file their preliminary objections and serve on the complainant and adjourned further proceedings to 26 October.

Part of the new charge read, "that you Bola Tinubu, former governor of Lagos state, being a public officer and listed in part II of the Fifth Schedule to the 1999 Constitution of the Federal Republic of Nigeria and Federal Republic of Nigeria and having subscribed to the oath of office as contained in the Fifth Schedule of the constitution on assumption of office between 1999-2000 and while in office as such, engaged yourself in

the operation of several foreign bank accounts.

That you Bola Tinubu, former Governor of Lagos state, being a public officer and listed in part II of the Fifth Schedule to the 1999 Constitution of the Federal Republic of Nigeria and having subscribed to the oath of office as contained in the Fifth Schedule of the constitution on assumption of office between 1999-2000 and while in office as such, misinformed Code of Conduct Tribunal by stating in the form CCB1 that you do not have foreign accounts contrary to section 15 (2) of the CCB and T Act, Cap C15, LFN 2004 as amended and punishable under paragraph 18, Fifth Schedule to the 1999 Constitution as amended.
