Nigeria's inflation rate eased in February as the removal of fuel subsidies had a more muted impact on prices than forecast, strengthening analysts' expectations that the Central Bank will hold interest rates unchanged on Tuesday.

The government scrapped subsidies on petrol imports on January 1 but nationwide protests led to their partial reinstatement.

Fuel prices stayed higher than before the subsidy was

Abeokuta Controversy and confusion

have trailed the death of an Egba High Chief, Apagun Stephen Oluwole Olumide as some people believe his



sudden death needs to be thoroughly investigated before his remains are interred.

P.M.NEWS had earlier reported the death of the prominent Egba Chief, a bosom friend of the former governor of the state, Otunba Gbenga Daniel. Report had it that he would have clocked 70 years in May this year and he was suspected to have committed suicide by plunging into an artificial lake, Lake Toria, at the Golf Resort in Abeokuta last Friday. The lake

An unidentified police ser-geant attached to Area 'C' Police Command, Iponri, Su-

rulere, Lagos, allegedly went beserk and shot a truck driver on his left hand and a strav bullet he fired killed another person while he was making efforts to escape from the scene of the incident to avoid being

lynched by an angry mob.
Aneyewitnesstold P.M.NEWS that trouble started when the cop

with about five others who were operating in a (danfo) commuter bus blocked the truck with a Lagos registration number RV538 EKY driven by Saheed Mufutau. The incident occurred at Jimoh Odutola Street, by PHCN office, Surulere, Lagos


on Friday.

According to the source, the policeman, after checking the truck's particulars and they were up to date, demanded for a N20,000 bribe which the driver pleaded he could not afford because he was in the area to off-load empty containers.

During the ensuing argument, the sergeant allegedly shot the driver in his left hand. Sensing danger, his colleagues in the danfo bus sped off and left the sergeant to his fate.

In his desperate bid to escape from the scene, the cop fired several shots into the air to scare

This afternoon at his residence in Surulere, Ita Eko, Abeokuta, the Ogun State capital, southwest Nigeria, a few metres away from the residence of the former President of Nigeria, Chief Olusegun Obasanjo, security was beefed up as people, mainly his political associates, thronged the place to pay their last respects as his remains will be interred this afternoon.

As at the time of filing this story, the corpse of the Apa-gunbote of Egbaland, was still being expected at his residence

The widow, Architect Bisi Olumide, was seen sitting with some of her friends while the children led by the first child, Femi, were still worried over the sudden death of their father.

The corpse of the high chief was deposited at the mortuary of Neuro Psychiatric Hospital. Aro, Abeokuta, where it was gathered that an autopsy will be carried out on his remains.

A family source who pleaded anonymity, told our correspondent late last night that the issue of his burial today was still a subject of an emergency meeting slated for today

"It is true that we concluded that Apagun should be buried tomorrow(today), but some of the family members are still insisting that the result of the autopsy be received before we bury him. This issue was discussed this evening (yesterday) and we have agreed to further discuss the matter first thing tomorrow morning. I will get back to you tomorrow," the source hinted last night.

When our correspondent visited the residence, a white mansion with black gate named Toria House' in the evening yesterday, some men were seen digging the grave where his remains will be buried and a grey Mercedes Benz, hearse with customised plate number TOS 5 was seen conveying a casket.

Commenting on the issue of a text message reported to have been sent to some people before his sudden death, one of the family members disclosed that he had not seen the message but read it as news just like other Nigerians.

I cannot say anything concerning the text mes-sage. I heard it in the news as every other Nigerian. Someone

the mob from lynching him. One of the bullets he fired hit Dotun Alawiye, a motor spray painter at a nearby workshop. He died instantly.

molara she was shocked to hear that her husband was killed by a stray bullet because he was an easy-going person who never got involved in any trouble.

"We had been married for 15 years and blessed with four children. How am I going to cope with the upkeep and training of the children?" she wept. She called on the authorities

to ensure that justice is done on the murder of her husband, while also soliciting for the assistance of kind Nigerians on the upkeep

of her four children.

Narrating his ordeal to P.M.NEWS on his bed at a hospital on Savage Street, Orile

around here was just telling me now that the message was also sent to his son, Femi, and I can' say how far that was true. But all the same, whether he sent text or not, he has died and I don't think that he wrote there why he did what he did. To God be the glory, he came, he saw and he conquered. May his soul rest

in peace."
Investigation conducted around the area this morning by our correspondent showed that all is not well within the family members as some were still insisting to see the result of the autopsy before he is buried.

This will come as a huge surprise to the market and no doubt lead to much focus as to what was behind the outcome," said Razia Khan, Head of Africa Research at Standard Chartered.

The increase in fuel prices no doubt had a contractionary impact on real disposable income. In some sectors, a slowdown in momentum had been evident for sometime, so pricing power, the key ingredient needed to see a translation into any meaningful secondary (inflationary) impact, was largely missing.

Consumer inflation eased to 11.9 percent year on year in February, from 12.6 percent in January, National Bureau of Sta-

tistics data showed on Monday.
The governor of the Central Bank of Nigeria (CBN), Lamido Sanusi, said in January he expected inflation to pick up to around 14-15 percent in the first half of this year, before moderating towards single digits by the

Food inflation, the largest component in the headline figure, eased to 12.9 percent in February, compared with 13.1 percent in January

The CBN meets to review policy on Tuesday. The unexpected easing in price pressures strengthens analysts' views that the benchmark interest rate will be held at 12 percent.

'The unexpected decline almost guarantees that the MPC (monetary policy committee) will keep the MPR (benchmark rate) unchanged, especially given the concomitant resilience of the exchange rate," said Samir Gadio, economist at Standard Bank.

The police at Olosan were alerted and they responded swiftly to restore normalcy They arrested Saheed and took to the station where he is

still being detained. Angered by the arrest of Alamala, according to a source, Akeem on sighting a JSS 1 student of Idiaraba Senior High School identified as Yusuf Adegbite shot him dead and escaped on Wednesday.

The police immediately cordoned off the entire battle ground to forestall a reprisal attack from Idiaraba boys, but residents are apprehensive about what would happen on the day the victim would be buried.

Narrating his dilemma to *P.M.NEWS*, the father of the deceased, Adegoke Akeem said, "my son told me he was going to Paul Oguntola Street in Mushin collect his note book from his friend. And at about 8 p.m, somebody phoned me to say that my son had been shot dead.

"When I got there, people told me that my son was walking along the road when Akeem Coordinator shot him dead be-cause he was an Idiaraba youth and that any time they set eyes on any Idiaraba youth, be he a student, they would kill him.

"I am now appealing to the Lagos State Governor Baba-tunde Fashola and the Lagos State Commissioner of Police to declare Mushin arms pro-liferation zone and order all landlords and tenants who own guns whether licensed or not, to surrender them.

Lagos State Government over the weekend unveiled plans for the 6th Lagos Economic Summit, also known as EHINGBETI 2012. This came as government declared it has implemented over 100 resolutions reached at past editions of the Summit as clear evidence of the resolve on the part of government to see that the Summit is not just another

talk shop held biennially.
Speaking at a Media Networking Session at the weekend at Eko Hotel and Suites, Victoria Island, Lagos State Commissioner for Economic Planning & Budget who down Planning & Budget who doubles as Chairman of the Lagos Economic Summit Group, Mr. Ben Akabueze noted that while the first three editions of the Summit were largely diagnostic in approach dedicated to trying to analyse the problems, understand the challenges and what needed to be done, government shifted attention as from the fourth edition towards implementations.

Today, I can stand before you and tell you with all sense of responsibility that we have implemented over 100 of the 119 resolutions so far reached at past editions of Ehingbeti Summits. Those that have not been implemented or are on-going are those that require other partners like the Federal Government. This is why we feel confident to invite Nigerians and indeed the International Investment Community to yet another Ehingbeti where your time and resources would be worth your while going by the seriousness we attached to the Summit."

He also gave examples of the Bus Rapid Transport System (BRT), the Akute IPP, Lagos Island IPP, the on-going Lagos Light Rail System and the pattern of road designs with pedestrian walk ways as examples of key decisions reached at past Ehingbeti Summits.
Ben Akabueze who also

unveiled the theme of the 2012 edition of the Summit, "From BRICS to BRINCS: Lagos Holds the Key," explained that in the aspiration of Nigeria in the aspiration of Nigeria to join the league of the fast-growing BRICS economies (Brazil, Russia, India, China and South Africa), which will now change the acronym to BRINCS (including Nigeria), Lagos as the nation's economic capital with vast potentials and investment opportunities will play a central role. It is within this context and the place of Lagos as Nigeria's economic capital that this edition of the Summit will examine the economic potentials of Lagos. He noted that, Lagos is un-

deniably the economic nerve centre of the country hence it is referred to as the economic capital of the country. "Lagos consumes about 45% of the petroleum products in the country. This shows the high level of commercial activities in the State. On the average, 40% of bank branches are in Lagos

ness activities here. Over 40% of the telecoms subscriber base is here in Lagos. Two seaports in Lagos accounts for 70% sea trade in the country. The two electricity distribution companies Eko and Ikeja Districts account for 50% of PHCN's transmission power. About 80% of International air travel arrive in and depart from Lagos. All these point to Lagos as the economic nerve centre of the country. So, if Nigeria is being rated as one of the major players in the emerging markets, then you will agree with us that Lagos holds the key," Akabueze said.

He further explained that, in spite of all that Lagos contributes to the Nigerian economy, there is still a lot to be brought out in terms of the economic potentials of the State. "But it would take ideas, relationships and invest-ment to unlock these potentials," Akabueze noted. Also speaking at the Media Session, Economic Analyst and

Public Affairs Commentator, Opeyemi Agbaje noted that this is a moment of opportunity for Nigeria as an emerging economy saying, "at the moment Europe is back to recession but the emerging economics (BRICS)

are growing at about 7 %-8%. Interestingly Nigeria is also growing at about 7%. Lagos is not an oil producing State but because of its commercial and financial strength it dominates in other sectors like telecoms, law, medicine, architecture, engineering, transportation, power, insurance, capital market, media, entertainment, education and more. Lagos is a private sector driven economy. Growth in Lagos would have spiral effect on Nigeria as a whole. Lagos has the lowest level of unemployment in Nigeria at 7% compared to some States that has as much as 40%." Speaking in the same vein

at the event, an Investment Banker and Managing Direc-tor, BGL Investment Banking Ltd, Mr. Wale Oluwo explained that what has helped Lagos has been continuity and innovative thinking on the part of those managing the affairs of the tate. He noted that Lagos was the first State in Nigeria to come to the Capital Market to raise funds to finance infrastructure renewal efforts. He challenged the State Government to also inspire those managing the Local Governments to to think creatively.

ligerian Oil Expatriates lighest Paid in The World

A typical oil and gas executive in Nigeria earns
nearly half a million dollars
a year, chalking up the biggest premium for working
abroad over salary levels in
Britain, research released
today showed.

A typical senior oil and gas
employee in Nigeria will receive a supplementary country
premium worth 45 percent of
base pay, taking the total salary
to \$454,400 a year, a study by
the Curaon Partnership recruit-

ment consultants showed.

This trumps packages for executives working in Libys or trad, who could expect a total salary of around \$754,900, the research found.

Oil and gas workers from developed nations working in Migeria are paid well because of the number of projects that need international staff, local skills shortages and big cultural differences, the firm said.

"Whita Lagos is an exciting and well established place to

work for expats, oil & gas companies recognise that the incentives have to be high, because life as an expat in higgeria is so different from countries with broader industries and higher standards of living." Helen Di Mauro, a partner at the Curzon Partnership, said.

Oli industry exceutives information can expect a premium of 40 percent in Indonesia, 35 percent in Ghamand 30 percent in Libya, Kurdistan or Egypt, the research found.
