Prison Warder Shot Dead


An Inspector with the Nigeria Prisons Service, Mr Erezidor Ugo was allegedly killed by a policeman during a scuffle on Sunday evening.

The incident, according to an eyewitness, occurred opposite Wisdom Estate, along Nikton Road in the Kpansia suburb of Yenagoa, Bayelsa, Southsouth

Nigeria. The News Agency of Nigeria (NAN) gathered that the deceased, was shot in his house while entertaining two of his colleagues, who came to felicitate with him for buying a new car.

The sentencing proceedings of former Delta State governor, James Ibori in a UK court room started with drama this morning when dozens of his supporters who stormed the court in solidarity with him were bundled out by London Metropolitan Police.

Sahara Reporters which is covering the sentencing live reports that the hired supporters were transported to the court room by the Delta State government. They were bundled out when they started behaving unruly inside the courtroom.

The supporters who were singing praises of Ibori, it was learnt, caused serious disturbance by shouting and shoving the prosecutor and court officials.

Following the rowdiness, the court invited uniformed London Metropolitan police officers to sort out Mr. Ibori's hired supporters.

There was a standoff as court staff ordered people to go back to the open hallway and wait for

NAN reports that the family of the deceased had at about 7 pm retrieved the corpse from the hospital and placed it at the entrance of the Police Command Headquarters, demand-

ing for "justice".

Security had been beefed up in and around the police headquarters to avert any break down of law and order.

in prison. On 27 February this year Ibori pleaded guilty in a Brit-ish court to siphoning off \$250 million of Nigerian state funds

which he spent on luxury houses,

cars and a private jet, police said.
James Ibori, who was governor of Nigeria's oil-rich Delta State between 1999 and 2007, admitted ten offences relating to conspiracy to launder funds, money laundering and one count of obtaining a money transfer by

deception and fraud.

The 49-year-old was remanded in custody following the hearing at a London court.

During his two terms as gov-

ernor, Ibori "systematically stole funds from the public purse, secreting them in bank accounts across the world," London's Metropolitan Police said in a statement.

"His methods included the inflation of state contracts, kickbacks and the straight lift of cash from the state accounts by unscrupulous employees in his inner circle.

Ibori, who lived in Britain in the 1980s, came to the attention of London's Metropolitan police in 2005 and two years later a London court froze his British assets, million (now \$55 million, 41 million euros).

Despite earning less than \$25,000 a year as governor, his portfolio included a £2.2 million house in the upmarket London district of Hampstead and a £3.2 million mansion in Johannesburg's wealthy Sandton district in South Africa. He owned a \$20 million pri-

vate jet and also spent money on fees for exclusive British boarding schools and expensive

Ibori was first arrested by the Nigerian authorities in December 2007, after losing immunity after leaving office.

The winner, who the bank says will be chosen by "consensus" as early as Monday, will replace current President Robert Zoellick, the former US diplomat who will leave at the end of his five-year term in June.

The position is crucial for much of the developing world. The president oversees a staff of 9,000 economists, development experts and other policy specialists, and a loan portfolio that hit \$258 billion in 2011. Last year the bank committed

\$43 billion to new loans and grants, helping diverse countries to develop infrastructure, administration, and key sectors

of their economies.

Like the leadership succession last year at the IMF, the race to head the Bank has sparked muscle-flexing by newly empowered emerging economies and poorer countries who have called for a more open process based on merit.

The entry into the race of Ocampo and Okonjo-Iweala,

both respected economists, forced some discussion of the bank's development mission.

"Before, when there was only one candidate, the US backing counted for 99 percent and merit for one percent," said former Bank economist Uri Dadush

"Now, with several candidates, merit counts more. But

it is not the essential thing."
Even so, the US nomination of Kim, a medical doctor with deep experience fighting HIV/ AIDS in developing countries and head of prestigious Dart-mouth College, marks a signifi-cant change from the American bankers and diplomats who have been tapped to lead the Bank in the past.

"It's time for a development professional to lead the world's largest development agency, President Barack Obama said when announcing his nomination in March.

But critics worry Kim's experience is not broad enough to handle all of the fields the World Bank deals with, from infrastructure development to environmental protection.

CNPP Slams Lagos Doctors Over Strike

The Conference of Nigerian Political Parties, CNPP, Lagos State Chapter comprising 25 political parties, has condemned incessant strikes by doctors in Lagos State public hospitals.

A statement issued by CNPP called on the doctors to always resort to peace and dialogue in settling dispute rather than resorting to strike all the time-to press home their demands.

The statement was signed by CNPP State Chairman, Akinola Obadia; Secretary, Pastor Ayo Akintayo; Publicity Secretary, Dr. Smart Ofonyiri and Treasurer, Chief Emisbata Balogun.

CNPP said it viewed with grave concern the three-day warning strike upon by doctors in Lagos, saying that without prejudice to the rights of the doctors to seek a better welfare package, "we wish to warn against any act that could seriously jeopardise and threaten the precious lives and health of the people. We totally condemn

the strike in its entirety."

They said: "Whatever grouse they may have with government on the implementation of CON-MESS and taxation of doctors must be weighed against the precious lives that may be and will definitely be lost because of their strike

lives with his family.

A source told our correspondent that the inspector and his late wife were living separately due to a misunderstanding prior to the incident. But the late Caroline usually visits the barracks to see her children. Often, she slept at the barracks during such visits, it was learnt.

On the day of the tragic incident, the late Caroline arrived at night and slept with her husband on the same bed in the parlour, while the children slept in the bedroom.

According to one of the daughters (names withheld) who spoke to the police, "my daddy and mummy have not been living together because of a querrel they had in the past. But mummy usually comes to check us and gives us something. She would also sleep.
"But between Thursday night

and Friday, when she came, she slept with daddy in the parlour, on the same matress because daddy usually sleeps in the

The 43-count criminal charge included stealing of public funds, illegal deduction of local government funds and diversion of public funds.

While throwing out the case last month in Abeokuta, the Ogun state capital, southwest Nigeria, the presiding judge, lustice Olanrewaju Mabekoje said that the appellants had failed to follow the constitutional provision required to file information containing tional provision required to file information containing indictable offences.

Mabekoje said: "trial leave of court is required to file in-formation containing indictable offences by any person in the

formation containing indictable offences by any person in the High Court. The EFCC failed to comply with section 340 (2) of the Criminal Procedure Law before filing the information. Therefore, the information is liable to be quashed.

"EFCC has made a fundamental error and based on their failure to fulfil the constitutional provision, the court cannot go on to hear the case unless the right thing is done."
