Continued From Pg.1 said: "It was glaring that Sarah desperately wanted to marry Ade, to the extent that she was impregnated by him.

When the relationship started, the deceased's brother had to go to their father at their home town at Akoko area of Ondo State, Southwest Nigeria, to dissuade his daughter from doing what was wrong. But David was shocked that their father supported the relation-ship, claiming that Sarah, who later converted from Islam to Christianity through her elder

brother, must marry Ade."

P.M.NEWS investigation revealed that last Saturday Ade went to pick her from her brother's house to follow him to his house at Kampala West Nar'ya, aduna, where he resides with his first wife, Salamotu.

The tragedy occurred on Monday when the first wife and her husband had gone to their shop together and after about an hour, the first wife (Salamotu) told her husband that she was going home to cook for her children. And on getting home, she met the second wife sleeping.

She took a knife and stabbed Sarah to death.

She was caught in the act by one of her children who later the raised alarm. But before neighbours got inside, Sarah was dead, while the suspect was arrested in the toilet where she hid herself with the blood stained knife she used in stabbing the deceased.

She is presently being detained at the State Criminal Investigation Department, SCID,

She reportedly told the police that she had warned her husband not to marry another wife.

service in Lagos, southwest Nigeria, predicted that within 60 days an African head of state would die suddenly due to sickness

The prediction, P.M.NEWS learnt, was not taken seriously in many African countries until 5 April when the Malawian President collapsed during a meeting and was declared dead on arrival at the hospital.

The sudden death of Mu-

tharika and the latest prediction by T.B. Joshua that another old African head of state would soon fall critically ill and be hospitalised, have thrown many African countries into panic, especially Zimbabwe, where octogenarian President, Robert Mugabe, is battling with lingering poor

Last year, leaked US diplomatic cables quoted the Zimbabwean Central Bank Governor, Gideon Gono, as disclosing to the American Ambassador that doctors had told Mugabe he had prostate cancer and could die in 2013.

Since Mutharika's death, stories on T.B. Joshua, his healing, predictions and miracles have been front page news in Zimbabwe, Malawi, Zambia and a horde of other southern African countries where the 49-year old preacher and healer from Ondo State, southwest Nigeria, is

extremely popular.
In Zimbabwe, it was learnt that the ruling ZANU PF is attempting to block T.B Joshua's visit into the country scheduled for 25 May against the wishes of millions of people in Zimbabwe where T.B. Joshua has sometimes been portrayed in media reports as a power broker since Zimbabwean Prime Minister, Morgan Tsvangirai, visited his church in 2010.

T.B. Joshua's Christian television station called Emmanuel TV which is available on satellite and on the Inter-net via the Streaming Faith broadcast portal is watched by millions of people in western, eastern and southern Africa.

Killed, 6 Injured

Fifteen persons on Thursday lost their lives while 6 others were injured when a commercial bus collided with a car on Maiduguri-Damaturu road.

Eyewitnesses told newsmen in Maiduguri that the accident involved a mass transit bus owned by the state government's transport company, the 'Borno Express' and a Volkswagen Golf saloon car.

One of the eye witnesses, Mr Simon Mamza, told the News Agency of Nigeria (NAN) that the incident occurred around 2.35 pm in Jakana village, about 35 kilometres from Maiduguri.

He said the crash was caused by wrong overtaking.

Robbers Raid Hospital Pay Point, Kill Soldier, Cashier

Patients and medical personnel at the University of Port Harcourt Teaching Hospital, UPTH, were thrown into day when they heard sounds of gun shots from a gang of four armed robbers that killed a soldier and a cashier.

The attack took place at Sterling Bank pay point at the Emergency Ward of UPTH.

Reports reaching P.M.NEWS this morning said that the explosion at the Rumuokoro junction yesterday afternoon overshad-owed the robbery attack at the hospital that happened almost

at the same time.
It was gathered that armed robbers had shot the unarmed soldier in uniform accompanying a patient to hospital. Eyewitnesses told PMNEWS the incident caused panic at the

hospital.
The robbers carted away huge cash and escaped around Abuja campus.

Ben gbulem, the Rivers State Police Command spokesperson confirmed the incident.

"Yes. I can confirm that a gang of four armed robbers robbed and shot a Sterling Bank

robbed and shot a Sterling Bank Cashier at the Emergency Ward cash pay point and a soldier at about 5.45pm," he said.

Dr Diamond Tamunokuro, the Chairman of Association of Residents at the UPTH, said that hospital which is supposed to be safest place to secure lives can be under attack shows that the UPTH environment is no more safe for patients and medical personnel.

Aneyewitnesstold P.M.NEWS that the two robbers were trying to rob an owner of Toyota Camry inside the traffic jam. But policemen on patrol sighted the suspect who got down from the motorcycle and pointed his gun at the car owner.

But immediately he sighted the police, he took to his heels, shooting into the air to scare away people from attacking him. The policemen, the source said chased the fleeing suspect to Adeola Odeku Street where he jumped into a residential compound and threw his pistol inside the gutter. inside the gutter.

But the robber was later arrested with the help of the security guard at the compound.

The pistol was also recovered from the gutter by the police and youths who assisted the police in pursuing the robber. But his accomplice escaped in their motorcycle.

The incident caused stampede on the busy street as people ran for their lives to avoid being hit by stray bullets.
