Seven persons were crushed to death by a truck near Ginbidorowa Village, in Wukari Local Government area of Taraba state in the early hours of Thursday. According to an eyewitness,

the incident occurred at about

l a.m. when a gang of armed robbers blocked Wukari-Jalingo road and forced passengers in a luxury bus travelling from Onitsha, Anambra state to Yola, Adamwa State to lie face-down at the centre of the road at gun point.

The eyewitness further added that a truck loaded with cement ran into the road block mounted by the robbers and ran over the passengers, crushing seven persons to death

instantly.

The robbers immediately fled the scene of the attack shortly after the seven people were killed.

The Divisional Police Officer, DPO, of Agbado Oke-Odo, Chief Superintendent of Police, CSP, Akin Omolaoye could not be reached for comment on the incident as he did not pick his calls when contacted by *P.M.NEWS*. He did not reply the text message sent to him either.

When contacted, the Lagos State Police Command Public Relations Officer, PPRO, Deputy Superintendent of Po-lice, DSPNgozi Braide said she was not aware of the incident, but promised to call back.

At the time of filing this report, the PPRO had not called.

Aero Contractors has acquired more helicopters to accommodate more companies in the oil and gas business, the airline said vesterday during a media tour of its facilities in Port Harcourt, Rivers State, south south Nigeria.

Aero now manages 10 helicopters and caters for executives and staff of the Nigeria National Petroleum Corporation, NNPC, Total, Conoil and Adax Petroleum, among others.

The airline regularly flies the

governors of Rivers, Bayelsa and Akwa-Ibom States, said Captain Patrick Agbonlahor, General Manager and Head of Flight Operation at Aero Contractors in Port Harcourt.

The airline also provides sport hire services which costs \$9000 per hour or N1.3 million,

With four of the helicopters belonging to the airline, five owned by the NNPC and one owned by the Rivers State government, the airline has made plans to acquire more helicopters this year and next,

Agbonlahor said.
He said, while the oldest helicopter in their fleet is 23 years old, the newest is just a year old, adding that Aero helicopter arm of the airline employs 55 ground staff, 39 engineers and 48 pilots among them 22 captains

them 22 captains.
"We also have a state-of-theart simulator for training which at simulation for training which we purchased from Switzerland at \$400,000 (N60 million)," Agbonlahor said.

A brand new helicopter, he said, gulps about \$14 million (N2.1 billion).

Baale's Wife Sent To Jail For Child Theft

Wife of a traditional ruler (Baale) of Okugbolu village in Ijoko, Ota, Ogun state, south-west Nigeria, was Thursday docked at an Ota Magistrate's Court 3, over child theft.

She was charged to court by

the police in charge number MOT 848C/2012.

The first count read: "That you, Kudirat Fashola Kudaisi, 36, female and Taibat Hassan, 43, female on the 14th day of July, 2012, at about 1015 hours at Okugbolu Village, via Ijoko in the Ota Magisterial district did unlawfully entice Iyabo Idowu, female, by promising her that you will train her in school and collected from her a day old baby and thereby committed an offence contrary to and punishable under section 371(2) of the criminal code Vol. 1 of the amended laws of Ogun state of Nigeria, 2006.'

Count two reads: "That you Kudirat Fashola, 36, female, on the 14th day of July, 2012, at about 1015 hours at Okugbolu Village, Via Ijoko in the aforementioned magisterial district did unlawfully conspire with each other to steal a day old boy from Lyabo Idowu, female and from Iyabo Idowu, female and thereby committed an offence contrary to and punishable under section 516(1) of the criminal code, Vol. 1 of the amended laws of Ogun state of Nigeria, 2006."

Trouble began for the accused when Iyabo Idowu, 17, a JSS3 student of Community High School, Agege, was allegedly impregnated by her boyfriend and after her boyfriend refused to accept responsibility for the pregnancy, she explained her plight to her mother, Mrs. Taibat

Unknown to Iyabo, her mother had informed the Baale's wife (Kudirat Fashola Kudaisi) who was desperately in need of a child for the Baale, about her predicament and that was how the child allegedly ended up in the arms of the Baale's wife illegally. P.M.NEWS further learnt that

Kudirat had allegedly lied to the Baale that she was pregnant and he pampered her so much. And when Iyabo delivered a baby boy, her mother quickly took the

She wanted to have at least a child for the man at all costs because she knows that the man has land and other property. Can you imagine that for the whole of nine months she tied plenty clothes round her waist in order to deceive her husband that she was pregnant?

"She claimed to have given birth to the child yet she could not breast-fed the baby."

Further investigations revealed that the baby has since been taken to Red Cross Motherless Babies' Home in Ota, Ogun state, for proper care.

Contempt: Task Force Boss Risks Jail

A Lagos High Court sitting in Ikeja has ordered the chairman, Lagos State Task Force on Environmental and Special Offences otherwise known as Task Force, Superintendent of Police, Bayo Sulaimon to steer clear of the land at Olayiwola Street, New Oko-Oba, near Agege, Lagos or risk going to jail for contempt of court.

In a summon for contempt of court (civil form 48) filed today before the court, the vice chairman of the task force, Superintendent of Police, Mr. Agboola, was also joined as a

co-contemnor.
Alhaji Jimoh Arowolo, Chief Kafara Arowolo, Chief Adisa Sule Okiti and Mr. Jibrilla Ibikun for and on behalf of the Olarokun family had sued Taiwo Ogunyade and Mr. Remilekun Ogunyade for and on behalf of Olarokun/Orisade family, over the parcel of land at New Oko-Oba, near Agege. Inthe suitnumber ID/1313/98,

Justice Mrs. M.O. Obadina delivered the judgement on 2 June, 2009 and ordered that the Olarokun family are the ones entitled to a grant of certificate of occupancy over the disputed

In disobedience of this order, the Task Force on Monday stormed the area with armed policemen and arrested 13 members of the Olarokun family.

The office of the family at Olayiwola Street, New Oko-Oba is still shut while the agent to the family, Taiwo Ologunde, was declared wanted.

Lagos ACN Siams PDP **Over Ogun LG Polls**

The Lagos State chapter of the Action Congress of Nige-ria, ACN, has lambasted the People's Democratic Party, PDP, for its criticism of the conduct of the local govern-ment election in Ogun State.
