Miscreants stab apprentice to death, rob boss of N50,000

A group of miscreants has been accused of killing a 21-year-old man identified as Kazeem Rasaq at Aladeogun, Ilogbo-Eremi, Oko Afo area of Lagos State.

The deceased, *Sunday Sun* learnt, was in the company of his boss, Mr. Olamilekan Murital, a bricklayer and a co-apprentice simply identified as Toheeb when the miscreants numbering about 15 attacked them.

The hoodlums who were suspected to have acted on a tip-off, it was learnt, had trailed the deceased's boss who was said to have just received the sum of N50,000 from one of his clients to the spot where he was attacked along side his two apprentices.

Narrating the incident, the deceased's boss said no sooner had they stepped out of the place where he collected the money than the group attacked them with one of the hoodlums whom he identified as Ridwan Lukmon hitting him with a rod.

Olamilekan who claimed to have lost consciousness after he was hit on the head said he only got to hear

of Kazeem's death after he regained consciousness the following day.

Meanwhile, *Sunday Sun* gathered that a member of the group responsible for the attack has been arrested. The suspect, who was arrested three days after the incident denied being among the group that launched the attack claiming he was informed that a member of the group who he identified as Osama killed the deceased.

The suspect, who identified himself as a member of a social club known as White Island Boys Club, identified the alleged killer as the vice-chairman of the club.

"I know Osama very well. He is the Vice-Chairman of our club. The name of our club is White Island Boys Club. We hold meetings together. We are all well known in the community because of the good voluntary services we render in the area such as construction of wooden bridges across canals, clearing of bushy paths and general sanitation.

He listed some other members of the group that allegedly carried out the attack to include: one Roro (identified as Chairman), Osama (Vice-Chairman and the alleged killer of Kazeem), Daduro, Big 90 and himself.
