CP frees woman accused of stealing plantain, gives her N10,000

THE Commissioner of Police Lagos State, Fatai Owoseni, yesterday ordered the release of a woman with her child from custody. The woman was kept in custody for allegedly stealing plantain in Agbowa area of the state.

The unidentified woman was accused of stealing the plantain by a woman in one of the markets in the area on Saturday.

The woman and her baby were later handed over to the policemen from Agbowa division for proper investigation.

Daily Sun gathered that elders in the market prevented the woman and her baby from being lynched by a mob, after she was accused of stealing the plantain by the owner.

Owoseni ordered her immediate release during his unscheduled visit to the station. He asked the Divisional Police Officer to set the lady and her baby free unconditionally.

The lady during an interview by Owoseni explained that she was forced into stealing the plantain because she and her baby were hungry. The police boss, however, gave the lady N10,000 and warned her never to repeat the act again and to take proper care of herself and the baby.

One of the elders, Akinloye Adelusi, said if not for the timely intervention of the commissioner, the woman and her baby would remain in detention.

He said: "if not for quick intervention of the state Commissioner of Police, the woman would have remained in police custody for a week, because she wouldn't be able to pay herself out and she may end up in court and later in prison."
