MORE than 50 soldiers have been been reportedly drafted to Ajakurama and other neighbouring communities in Ovia South West Local Government Area of Edo State in a bid to apprehend the killers of a soldier and recover his stolen gun.

The late soldier, who was buried in a shallow grave by his killers, was on a routine patrol in the area when he and others were ambushed.

It was learnt that many of the villag-ers have fled for fear of being attacked while others were stopped from leaving their homes.

According to sources in Ofunama and Ajakurama, many of the villagers fled through the river to take refuge with

their relatives in Benin City.

Spokesman for Ajakurama community, Edah Tam Nike, expressed shock at the treatment being meted by the soldiers to the villagers, despite the pledge by the community to join in the

search for the culprits.

He said the villagers were not allowed to leave because the soldiers were concerned about the gun.

However, spokesperson for Opera-tion Delta Safe, Major Ibrahim Abdul-Iahi, denied that the soldiers harassed

community members.

He said soldiers were only carrying out a surgical operation to isolate hood-lums, and urged the villagers not to be afraid but to go about their normal du-
