Ironically, the Federal Government still wants to ride on judicial wings to prosecute me, when it does not comply with orders that proceed from the court, especially in relations to me.

"At this point, I strongly believe that there must be an end to this hypocrisy and lopsided /partisan rule of law. Since the Federal Government has resolved not to comply with judicial orders directing my release, it is better for the court to also absolve me of the need to submit myself for further prosecution. Justice should be evenly dispensed, as opposed to same, being in favour of the Federal Government of

TWO persons have been beheaded by gunmen suspected to be members of a notorious cult group in Choba community in Obio-Akpor Local Government Area of Rivers

gressives Congress (APC) in Delat State. Meanwhile, the governorship candidates of the party in the state, Chief Great Ogboru, and the Independent National Electoral Commission (INEC) have asked the court to throw out the suit.

Nwaeze submitted that the court does not have jurisdiction to determine the matter as presently constituted. Similarly, Nelson Imoh, counsel to Ogboru, objected to Ochei's suit because it was not initiated by due process, insisting that the court has no jurisdiction to entertain the case as constituted.

Imoh posited that the procedure for the enforcement of an extant judgment of court in an event of

Justice A. Chikere delivered on June 19 is an existing judgment that has not been appealed against nor set aside. He, therefore, held that the present court is a court of coordinate jurisdiction and at par with the court of Chikere.

"This court has no jurisdiction to add to, extend, remove from, substitute and or expand the content, purview, tenor and the application of the consent judgment of Justice A. Chikere delivered on the 19th day of June, 2018.
