## Bandits kill 12, abduct 21, in fresh Kaduna, Katsina attacks

**BANDITS** have killed no fewer than 12 persons while 21 people were abducted in fresh attacks of some communities in Kaduna and Katsina states. A youth leader, Abashe Dauda, told Daily Sun that 11 bodies were discovered at Gaida Kaso and five others missing when gunmen launched an offensive on Gaida Kaso and Wako Kaso

> An eyewitness said that the armed bandits stormed into Batsari community at about 10:20pm and started shooting sporadically before they abducted 21 persons, mostly women and children, while a man simply identified as Alhaji Hassan was shot dead.

Efforts to get the police authorities in Katsina State to comment on the incident proved abortive as the spokesperson, Gambo Isah, did not respond to calls to his phone.

The police command had, earlier on Tuesday night, confirmed the abduction of a judge, Alhaji Husaini Sama'ila, by gunmen at a Shari'a Court at Baure Zaka village in Safana Local Government Area of the State. The judge was said to have been kidnapped around 3:00 pm, on Tuesday, while on a personal visit to the court.

The police spokesman: "As you all know, the court has not been on the session since the commencement of the strike action embarked by the Judicial Staff Union of Nigeria (JUSUN).

"The judge took the risk and went to the court. He didn't inform the police about his going to the court, knowing fully that the place is not secured enough," he said.

## Customs uncovers 1387 cartons of tramadol concealed in ceramic tiles

THE Nigeria Customs Service, Area Il Command Onne Port in Rivers State has uncovered 1387 cartons of prohibited Tramadol tablets concealed with 1000 cartons of ceramic tiles.

Customs Area Controller (CAC) of the Command, Auwal Mohammed, in a statement said it was found

"Hundred percent examination is one of the key aspects of the clearance procedure in Nigeria. Therefore, all importers should know that making unclear or false electronic declaration does not mean they will have an easy way out with their consignment.

"Every container that arrive Onne Port must be subjected to 100 percent examination after relevant duties and charges have been paid and necessary procedures followed. But no compromise to examination and all cargoes must be examined. And this is one of the results you are seeing here.

"Ordinarily, you can see that the same carton used to package the ceramic tiles is what was used to package the tramadol," he said.
