Gunmen kill 3, injure many, abduct ex-SSG's family, 3 others in Taraba, Katsina

AL least one person was reportedly killed and several others injured when gunmen kidnapped the family of former Secretary to the Taraba State Government, Gibson Timothy Kataps.

Taraba State Police Public Relations Officer, Mr. Usman Abdullahi, said the incident occured around Jamtari Gayam, in Gashaka LGA of the state.

Abdullahi said that the family was on their way to Jalingo from Gembu after the Yuletide break when they ran into the gunmen.

He said the gunmen went away with the children after they killed a villager and injured some persons, including the police officer who was escorting the family.

Abdullahi, however, stated that the police were on the trail of the kidnappers and were working hard to ensure the safe return of the victims.

Chairman of Gashaka LGA, Mr. Paul Dogoh, who also confirmed the development, said he would convene a security meeting to appraise the security situation, especially in the area

The deceased officers, Police Inspectors Isaac Isodje, Saviour Udeh and Ebenezer Edward, who served under Diobu Division of the Rivers State Command, were killed by gunmen during a stop-andsearch patrol in November, last year.

Presenting the cheques on behalf of the governor to members of deceased officers' families, the Commissioner for Information and Communications, Paulinus Nsirim, said the gesture was Governor Wike's demonstration of his commitment to ensure that the families of policemen who lost their lives in the course of serving the state
