## Harvest of arrest as NDLEA smokes out Abuja drug traffickers

THE National Drug Law Enforcement Agency (NDLEA) has arrested six persons in Abuja for selling drug cookies and noodles during a raid on a relaxation centre, popularly called garden.

In another operation, operatives of the agency intercepted United Kingdom and Saudibound cocaine concealed in synthetic hair.

The raid in Abuja followed credible intelligence, as operatives raided the garden at Wuse Zone 5, behind Shoprite, where a lady, Rachael Famiyesun, 29, who deals in drug cookies, was arrested along with her salesgirl, Stella Sunday, 20. Besides the cookies, they were also caught selling bottles of black currant drink, popularly called Zobo, prepared with cannabis.

Meanwhile, a statement by the NDLEA's director of media and publicity, Mr. Femi Babafemi, disclosed that another business operator in the garden, Moses Obi, 30, was ar-

Raids garden, markets rested with his salesgirl, Aisha Abdulrahman, 19, for selling noodles prepared with cannabis. A barman, Ahonye Jonah, 31, who works with the owner of the garden, was equally arrested, while one of their customers, 38-year-old Ngozi Justina Emelogu, was also nabbed during the raid on Wednesday January 19.

Two days earlier, officers of the FCT command of the agency raided the Zuba Yam Market, where a drug dealer, Haruna Hassan, was arrested with 19.3kg of cannabis.

## Police nab man for scamming 121 job seekers

Inspector-General of Police Intelligence Response Team (IRT) has arrested a suspected serial fraudster, Hamza Abdullahi Gambo, for scamming 121 job seekers.

The suspect allegedly issued fake employment letters of the Nigeria Meterological Agency (NIMET) after collecting over N5 million from them.

The IRT team apprehended the suspect in Bauchi metropolis after one Beatrice Itodo reported that the suspect swindled her of N2,366,000 through fake employment letters issued to many of her relatives purported to be the by the agency.

The suspect, a former employee of NIMET, confessed to have issued the fake employment letters and that he was paid for doing so through his Guarrantee Trust Bank Account number 0018546542. He stated that he was a senior school certificate holder employed by the NIMET in 2003. He also that said he was dismissed, reinstated and later dismissed again.

Gambo confessed that he issued fake employment letters to 121 job seekers, designed with the agency's logo

and staff signature, before his arrest.

He admitted that Itodo paid N2,366,000.00 to him through his GTB account number for 15 job seekers initially and the fake employment letters with NIMET letterhead were issued to them through electronic mail addresses.

He confessed: "I cannot remember how nuch I collected, based on individuals, but the total amount is N2,360,000. I received the money via my account number as stated earlier."
