

# Troops kill 16 terrorists, injure scores in Kaduna

**MILITARY** troops have killed 16 terrorists and injured several others in two separate attacks carried out on notorious terrorists and bandits' hideouts in Kaduna State.

The feat is coming few weeks after the launch of 'Operation Show no Mercy, to wipe out bandits, terrorists, kidnappers and other criminals disturbing the peace in the state.

Military sources revealed that the air component of Operation Whirl Punch carried out the air interdiction missions against identified terrorists' hideouts at Alhaji Isiaka location and Kuduru in Igabi Local Government Area of Kaduna State, on Tuesday.

The strikes, as revealed by reliable sources, were suc-

cessful as 14 terrorists were eliminated with several others injured, adding that similar strikes were also undertaken at Udawa, along Kaduna - Birnin Gwari Road, in Kaduna State, after receiving intelligence reports of terrorists' activities of cow rustling in the area.

**AN** Edo State High Court in Benin, yesterday, remanded the Secretary of Benin Traditional Council, Frank Irabor and six others in prison, custody.
