## Polls: IGP orders movement restriction on election day

THE Inspector General of Police (IGP), Usman Baba, has ordered the restriction of vehicular movement during the governorship and state house of assembly elections

The Force Public Relations Officer, Olumiyiwa Adejobi, who made the disclosure, said the restriction would take effect from 12 midnight today to 6pm tomorrow.

Adejobi, in a statement he issued in Abuja, yesterday, said: "Sequel to the forthcoming gubernatorial and State Houses of Assembly elections scheduled to hold on March 18, 2023, the Inspector-General of Police (IGP), Usman Alkali Baba (CFR), has ordered the restriction of all forms of vehicular movement on roads, waterways, and other forms of transportation, from 12am to 6pm on election day in all states where elections will be conducted, with the exception of those on essential services, such as INEC officials, electoral observers, accredited media and observers, ambulances responding to medical emergencies and firefighters, etc. This directive excludes the Federal Capital Territory as no election is being conducted, therein.

Similarly, the IGP reiterates the ban on all security aides to VIPs and escorts from accompanying their

principals and politicians to polling booths and collation centres during the election. State-established and owned security outfits/organisations, quasi-security units, and privately-owned guard and security outfits are also barred from participating in election security manage-

The IDP, therefore, urges all citizens to be law abiding

during and after the elections, even as he assures that all necessary security arrange-ments have been emplaced, to ensure they exercise their franchise unhindered. He also urges the general pub-lic to contact the Nigeria Police Force Headquarters via 08033440189 (DIG Op-erations), 08033027731 (AIG FEDOPS), and 08034040439 (CP Elections), the 'NPF Rescue Me App' on Android and ios, and via the NPF Rescue Me Emergency Toll-free line on 08031230631, to request emergency security response. Similarly, other election situation room numbers which have been shared on Nigeria Police social media platforms will be repeatedly released by concerned State Police Commands for necessary emergency contact.

## DSS arrests 2 over call for violence in Kano

THE Department of State Services (DSS) has arrested the duo of Sharu Abubakar Tabula and Isma'il Iliyasu Mangu for allegedly inciting violence in Kano State.

A statement signed, yes-terday, by the spokesper-son of the Service, Peter Afunanya, accused the suspects of separately recording messages, which they shared through various social media channels.

"In those potentially harmful messages, they specifically championed certain political interests and directly called on their supporters to violently attack those opposed to them, including security personnel, during Satur-day's governorship and House of Assembly election in the state," he stated. He added: "As a result of

this development, a particular political party in Kano has threatened to organise protest marches in the metropolis as well as storm offices of some of the security agencies on 16th March, 2023 in solidarity

for the suspects.
"While the Service alerts the public of this planned illegal action, it calls on the concerned party to shelve it forthwith or be ready to face the consequences.

The DSS assured that it will not idly watch misguided persons or groups undermine the peace and security of the state.

"The leadership of the said party should rein in its members and urge them to desist from conducts capable of causing a breakdown of law and order in Kano and its environs before,

during and after the sched-uled election," he stated.

The Service reiterated the call for political players to abide by the letters of the electoral act and guidelines

"All and sundry are advised to positively contrib-ute to the sustenance of

peace and democracy in Nigeria," he stated. The New Nigeria Peoples Party (NNPP) in the state had accused the Service of bias against them, saying it was extending invitations to its supporters with a view to arresting and detaining them.

At a press conference ad-dressed by Dr Abdullahi Baffa Bichi on behalf of the party, they pledged to em-bark on a protest march to press for the redeployment of the Director of the Service in the state.
