HE Court of Appeal, Lagos Division, on Thursday, gave its nod to the request of the Nigerian Stock Exchange (NSE) for more time within which to appeal against the ruling of Justice Lambo Akanbi of a Federal High Court in Lagos, which annulled the election of Alhaji Aliko Dangote, as NSE president.

a motion on notice. brought pursuant to Section 24(4) of the Court of Appeal Act, 2004 and under the inherent powers of the court, sought for an extension of time to appeal against the ruling delivered by Justice Lambo on August 4, 2010, which removed Alhaji Aliko Dangote as the NSE president.

The appellate court, presided over by Justice Ibrahim Saulawa, however, refused the second lower court had greatly prayer asking the court to deem the notice of appeal as properly filed.

The ICPC boss said no matter how well intentioned training for the CSOs might be, "the people who will be operating and networking with them should understand the philosophy of what they are doing and why they are asking certain questions and why they must provide answers."

He stressed that the

involvement of the local government officials would be more meaningful to them when they "understand that whatever they are doing, they are not doing it for somebody in Abuja or in their state capital, but they are doing it for their own children and other generations and that they are partners and stakeholders in the development of their country."

In his remarks, the UNDP Deputy Country Director, Janthomas Hiemstra, said the UNDP was interested in the preventive aspect in fighting corruption, but quickly added that "it is not because the enforcement aspect is not as important to Nigeria's populace."
