rant was said to have rushed to Ijan on Sunday morning from Lagos after a telephone call from one of the party's chieftains in the state.

Daramola's murder has also elicited many condemnations from well-wishers including the state governor, Mr. Ayo Fayose, the Inspector General of Police and many political leaders in the state.

**Explaining how the dastardly** incident occurred, sources at the residence of the deceased disclosed that the assailants who scaled the fence to gain entry into his premises had to force the door leading to his bedroom opened where he was slaughtered.

According to the source, there were clouts of blood all over the place especially in the bedroom where the incident took place.

When THISDAY visited the community vesterday, a usually quiet and calm environment, several bon fires were made on major roads in the town, just as

several houses including that of the state chairman of PDP. Chief Ropo Adesanya were set ablaze by angry youths who were protesting the murder.

Besides, a number of government official vehicles were also burnt while carcasses littered the streets.

Following the incident, a detachment of anti-riot policemen had been dispatched to calm the situation and prevent further damages to lives and

This development also forced Ijan Ekiti residents to flee the town and are currently taking refuge at neighbouring commu-

The incident demoralised citizens of the ancient town in view of his diposition and his willingness to assist the people and to facilitate what they considered as benefit for the generality of

At press time yesterday, the ancient city had almost become a ghost of its usual self, as people were no longer seen on the streets for fear of possible arrest or molestation by the security operatives

The state governor who briefed newsmen yesterday said the unfortunate incident has put Ekiti in the limelight while he placed a price of N5million on any one who could volunteer information on the murder.

"My goverment have had causes to express serious worry and concern on the conduct of some characters who do not see anything good in this government and the ruling party; who have adopted a brazing desperation as a tool for capturing

'My heart therefore bleeds this day as I receive the shocking news of the gruesome murder of Dr Ayodele Daramola, an emerging light in the present generation of Ekiti indigenes.

Fayose said "It is clear that the intention of these bloodhounds is to cause a spate of general insecurity across the length and breadth of Nigeria. As Chief Security in the state, I shall spare

no effort in ensuring the protection of lives and properties in Ekiti state.

The Inspector-General of Police, Mr Sunday Ehindero also described the gruesome assassination as a rude shock to the force.

Ehindero who spoke when he visited the state governor, over the incident vesterday said he was on his way from Bakkassi when he heard about the inci-

He told the governor that he had been to the Ijan-Ekiti residence of the deceased as well as the state hospital to see things for himself saying it was a clear case of assassination which police would get to the root of how it all happened.

Ehindero, who was accompanied by top police officers, including Ekiti State Commissioner of Police (CP), Mrs. Ivy Okoronkwo, also visited the hospital where the slain politician's friend, who was with him when he was shot, was receiving treatment.

The police boss was said to have interviewed the man and other witnesses in connection with the politician's death.

The police authority has constituted an investigative panel headed by the Deputy Inspector General of Police (DIG) in charge of 'Operations', Mr. Mike Okim.

The panel, which was already in the state, is expected to investigate the killings and submit reports back to the Force Headquarters, Abuja.

A gubernatorial aspirant on the platform of the Alliance for Democracy (AD) in Ekiti State, Mr. Ayo Arise lamented the assassination of Daramola. describing it as another setback to the state.

Arise said the development was very shameful to the entire state, arguing that the ploys of charlatans to intimidate credible Nigerians from participating in politics through this type of dastardly act will not work.

Congress of Democrats (ACD). Meanwhile, following report of Daramola's assassination, the ruling Peoples Democratic Party (PDP), has threatened to disqualify aspirants who fail to show leadership in curbing the excesses of their followers.

Rising from its National Working Committee (NWC) meeting yesterday in Abuia, the party said that it would insist on zero-tolerance policy on violence and acts and statements that were inciting and were likely to provoke violence.

A statement signed on behalf of the NWC by National Secretary of the party, Chief Ojo Maduekwe entitled: 'Confronting The Beast: PDP Says "No to Violence", urged authorities investigating the spate of killings not to rule out the possibility of "fifth columnist and agents-provocateurs syndicated for the purpose of casting the PDP in bad light".

The party said, that being the largest stakeholder in the nation's democratic politics, it had a lot more at stake in a peaceful transition than any other group, adding, "We cannot keep quiet in the face of this disturbing trend".

"Our concern is heightened by the arson in Ekiti State, following the killing of a PDP governorship aspirant and destruction of PDP Secret-ariat, PDP State Chairman's house, and properties belonging to other PDP members", it stated.

The party urged the Federal Government to mobilise all resources to apprehend those behind the disturbing pattern of killings "no matter how highly placed and no matter how many they are".

Police must be seen to deploy all their investigative arsenal to unravel these killers if the confidence of decent people in the vocation of politics is to be sustained.

"We urge our members not only to remain law-abiding, but to refrain from language and conduct that facilitate a culture of violence.

"All party leaders are hereby directed to adhere strictly to the provisions of the Party Constitution, the Nigerian Constitution, and the soon-to-bereleased Electoral Guidelines in the process of candidate emergence from the wide pool of aspirants at all levels", the statement

Bolaji Akinyemi, the former president said that the lecture formed part of a global manifestation the free \_expression of ideas, which he said was a critical element of the democratic process.

He, however, noted that while the major democracies were engaged with how to project democracy as an instrument of international power and global economic advantage, the "new" democracies of Africa were faced with a multiple challenge.

According to him, "First, we are challenged to select and distil from the various models of democracy. the form that is most appropriate to our various peculiar national circumstances.

"Second, we have to agree on the minimum expectations of the governed from those whom they empower to rule over them; third. those who assume the mandate of the people have to grapple with the imperatives of ensuring the stability and sometimes the survival of the very nation states they are elected to rule.

"Fourth, because the needs of our peoples remain basic and mostly existential, our new democracies are challenged to pursue strategies of economic development that sometimes violate some of the fundamental principles of democracy in a bid to deliver dividends quickly and to the greatest majority".

He said that Nigeria was today an embodiment of "these contradictory demands and mutually reinforcing imperatives in a very stark form", stressing "I believe the Nigerian experience with democracy in the last seven years especially has thrown up the major issues and problems of democratic transformation in present day Africa"

Babangida reviewed the state of

the nation over the years and concluded that issues that had long been presumed resolved have once again come to the fore "with greater clarity and compelling stridency".

According to him, "Minority rights are being expressed and pressed with increased militancy. Primordial cleavages have resurfaced and sometimes threaten the foundations of national cohesion."

In his lecture on the occasion, Akinyemi x-rayed the essence of democracy and posited that broad agreement and consensus on the great issues of today was sine qua non factor of democracy.

He said that that some issues had been settled while some had not yet been settled, pointing out that the issue of population remains controversial, adding, "the issue of revenue allocation, to a large extent, bears a relationship to the census issue and as long as the census figures remain controversial, the issue of revenue allocation will also remain controversial".
