It was gathered that the father of the three young men, one Alhaji Musa, a cattle dealer, negotiated with the kidnappers.
It was further learnt

that the kidnappers agreed on N60m ransom for the release of the three siblings and the motorcycle rider was hired to deliver the ransom to the abductors at a forest near the village.

However, the kidnappers

killed the four of them after collecting the ransom. It was learnt that the victims were buried on Monday in the village.
In a related incident,

The suspects, who were alleged to be behind most

of the kidnappings in the area, met their waterloo while trying to kidnap a cattle dealer in the area.

The police spokesman in the state, DSP Usman Abdullahi, confirmed the two incidents.

#### Family of 28-year- old graduate allegedly killed by cop petitions IGP

he family of 28-year-old Godsent Ob-hafuoso yesterday called on the Inspector General of Police, Alkali

Baba to prevail on the assistant Inspector-General of Police (AIG) Zone 5 to investigate the alleged murder of their son by a policeman, Inspector S. policeman, Inspector S. O. Ayemere on August 13,

Inspector Ayemere was said to have escorted a prominent man, Sunday Obhanogho to Uromi, Esan North East Local Government Area for a burial cer-emony and fired shots in the cause of the ceremony where bullets from the gun hit Obhafuoso and killed him.

In a petition to the IGP, the family through their lawyer, Olayiwola Afolabi Esq. alleged that the Zone

is foot dragging in the investigation of the matter.
The family said, "On the 13th day of August, 2022, Godsent Obhafuoso accompanied his matter identification." panied his master, identified as Mr Augustine Iyoha to Uromi for the burial of his mother-in-law and in the process one Mr Sunday Obhanogho arrived with a policeman from the Area Command in Uromi, Inspt. S. O. Ayemere and that while he was doing video recording of the party and also assisting his master to collect money being sprayed on him, the po-liceman released gunshots that hit a cameraman and also hit the ribs of Godsent, who was pronounced Brought In Dead (BID) at the Irrua Specialist Teach-

"We want justice for my late brother. I forwarded a petition to AIG Zone 5 on the 17th of August, 2022 and till now, nothing has been done on the matter.

"They charged me a mo

"They charged me a mo-bilisation fee of N200,000; the IPO in charge of the case at the Anti-Vice which I paid, they promised to go and car-ry out the arrest, but till date, they have not done anything.

"The body of my late brother was buried two weeks after, two days after an autopsy was conducted. My brother was killed one month after his graduation from Ambrose Alli University, Ekpoma where he studied Business Administration."
He claimed that he also
