While the altercation intensified, the policeman was said to have reached for his pistol and shot the soldier:

The soldier was pronounced dead at about 6pm.

Angered by the incident, colleagues of the slain soldier mobilised themselves to unleash mayhem on the community

The soldiers in retaliation, launched an attack on Ogijo Police Station where the mobile police officer was deployed by the Ogun Police Command.

The soldiers during the reprisal attack destroyed property; including a police armoured tank and police patrol vehicles.

Confirming the incident to journalists, the Police Public Relations Officer (PPRO) of the state police command, Abimbola Oyeyemi said the incident happened in Odongunyan area of Ikorodu in Lagos State.

Headded that, when the soldiers came for reprisal attack, they attacked Ogijo Police Station, burnt down the station patrol vehicle and armoured personnel carrier.

"Though, the cause of disagreement between the police officer and

the soldier is still sketchy as I speak with you now, but the incident really happened in Odongunyan area of Ikorodu, in Lagos state and when the soldiers came for reprisal attack, they came to Ogun Police station, burnt station, armoured personnel carrier and patrol vehicle.

"The commandant of the barracks at Ikorodu had been contacted and he is looking into the matter," Oyevemi said.
