Housewife dies after alleged sex romp with NDLEA zonal commander in Minna

woman identified as Mrs Christiana Williams has died after allegedly having a sex romp with a man said to be the Zonal Commande of the National Drug Law Enforcement Agency (NDLEA).

Minna, Niger State, identified

ried woman, who was said to be asthmatic had visited the house of the said NDLEA zonal commander on the pretence to sell underwear to him, but allegedly ended up having sexual intercourse and there after developed a crisis and slumped

New Telegraph learnt that the suspect rushed the woman to Bay Clinic, along Bay Clinic road, Minna on Saturday at

about 2pm and the death was confirmed by the doctors upon arrival before entering the hos-

A reliable source around the hospital who pleaded anonymity told our Correspondent that, "the suspect brought the dead woman naked, but went back home and returned with her pants, brassiere, and other clothing materials and wore them on her"

It was further learnt that it took the help of a good Samaritan who has a shop close to the scene to volunteer her car to rush the woman to the hospital, but she died on arrival.

However, when the hospital suspected foul moves, our Correspondent gathered, they quickly contacted the Police Statury and Tudun-Wada Police Statury at Tudun-Wada Police Statury S tion, following claims by the NDLEA zonal commander that the lady came to his house to supply underwear to him, and that she suddenly went into an asthmatic crisis while he rushed out to get an inhaler

Our Correspondent learnt that the said Zonal Commander of the NDLEA, Minna, Niger State, identified as Ferni is currently in the custody of the State Police Criminal Inve gation Department, SCID, for alleged culpable homicide.

It was gathered that Femi is suspected of complicity over the death of Mrs Williams at his residence situated along Bay Clinic Road, opposite old B.Y stores, off Shiroro road, Minna.

However, her husband, Mr. Williams who hails from Kogi State is said to be shocked and sad over the incident and claim that his wife who was asthmatic does not use an inhaler, but had some prescribed medications she uses whenever she had the crisis to resuscitate her.

The suspect, who was arrested by the Tundun-Wada Police Division, was later transferred to the State Criminal Investigation Department, CID, for further investigation.

When contacted, the state Police Public Relations Officer, PPRO, DSP Wasiu Abiodun confirmed the incident, adding that, the matter is currently under investigation.

Efforts to reach the spokesperson of the NDLEA failed as his number did not go through.

Man arrested as NDLEA intercepts cocaine, meth going to Vietnam, Brazil, Italy

_agency seizes Colorado consignment from Canada

businessman, Molokwu Nwachukwu, has been arrested by operatives of National Drug Law Enforcement Agency (NDLEA) at the Murtala Muhammed International Airport, Ikeja, Lagos.

The suspect was intercepted for concealing 36 parcels of cocaine in different parts of his check-in bags, hand luggage and two pairs of slippers, while heading to Southeast Asia.

The agency's spokesper-son, Mr. Femi Babafemi, in a statement yesterday said Nwachukwu was arrested at the screening point of the MMIA Terminal 2, while attempting to board his flight to Vietnam on Wednesday March 22. He said a total of 36 parcels - of whitish powdery substance which tested positive to cocaine with a gross weight of 1.00 kilogram were recovered

from the handles of his bags and soles of two pairs of slippers in his luggage

Babafemi said the suspect claims he travels frequently to China, Dubai, Pakistan and Vietnam, from where he imports baby wears that he distributes from his Onitsha, Anambra State base.

In the same vein, NDLEA operatives at the Lagos airport have thwarted attempt by a suspect, Chimezie Innocent Nwafor to export 2.10 kilograms of methamphetamine to Brazil

Follow up operations led to the arrest of three more suspects linked to the consignment at Oyingbo Market, Yaba, Lagos. They include: Ifeanyi Onu; Simon Nwuzor and Omini Thank-God Peter. The meth consignment was molded into 25 bars of local black soup called Dudu Osun and packaged in a carton for export to

A similar attempt to

export a cocaine consignment consisting of 300grams of raw cocaine and 200grams of phenacetin, a chemical agent used to adulterate and increase the volume of cocaine, concealed in packs of airfreshener; going to Malabo, Equatorial Guinea was also foiled by NDLEA operatives attached to the **SAHCO** exportshed at the Lagos airport on Monday March 20. the seizure. Police debunk report of arson by protesters in Ebonyi

he Police in Ebonyi State said no house was burnt during Saturday's protest in Ishiagu community Ivo Local Government Area of the state.

The News Agency of Nigeria (NAN) reports that some media outfits had reported that the palace of the traditional ruler; Moses Ngele was razed by

lations Officer (PPRO) in the state, SP Onome Onovwakpoveva told NAN on vesterday that calm has been restored to the community

"There was a protest by women of the community due to the death of one Arinze, suspected to be killed by gunmen.

"The women barricaded the roads, burnt tyres and vandalised some properties at the palace," she said.

The PPRO said that the protesters complained that leaders and prominent people in the community have been indifferent to the issue.

Mr Emmanuel Orji, a native of the community said the protest staged by women from various villages which make up the community was largely peaceful.
