he Ogun State Police Command has arrested 10 suspected cultists over the recent cult killings in the Sagamu area of the state.

The Police Public Relations Officer (PPRO) of the command, Abimbola Oyeyemi, confirmed the arrest of suspects to journalists in Abeokuta yesterday.

No fewer than five persons were reportedly killed in supremacy battle between members of the eive and aive cult groups in Sagamu in the past week.

A Superintendent of Police, identified as Morakinyo Adejumo sustained gunshot injuries during the cult clash.

The PPRO said the suspects were arrested on Saturday in different parts of Sagamu and Odogbolu areas of the state in the ongoing onslaught on cultist's activities.

Oyeyemi disclosed that, the suspects are members of the dreaded Eiye confraternity who have been unleashing mayhem on residents of Sagamu and its The suspects are: Adekoya Adesina, Ayinde Olumide, Adebayo Jamiu, Ajayi Temitope, Taiwo Olatunji, Oladapo Ayeye, Johnson Adeyemi, Tunde Banjo, Gbenga Morufu and Tunde Adenuga.

Oyeyemi said, "The suspects were arrested following information received by men of anti-cultists section that a group of cultists were converging at different locations in Odogbolu in order to unleash

terror on Sagamu in continuation of the supremacy battle going on amongst the various cult groups in Sagamu and its environ.

"Upon the information, the anti-cultism team mobilised and moved to the area.

"On sighting the policemen, the hoodlums attacked them with dangerous weapons, but they were subdued by the policemen after which 10 amongst the cultists were apprehended.

"SP Morakinyo Adejumo

was seriously injured during the operation and he was rushed to hospital where he is responding to treatment," Oyeyemi said.

The PPRO said, eight live cartridges and large quantity of weeds suspected to be Indian hemp were recovered from the suspects.

He added that the Commissioner of Police, Olanrewaju Oladimeji has ordered a massive manhunt for the remaining members of the group.
