attack to our correspondent in Jos () Also confirming the killings, vesterday said the attacks occurred around 11 pm, "we had a call that herdsmen came into Chisu and Bwai, this morning we confirmed the killings of 14 of my constituents while several houses were destroyed, properties burnt.

He condemned the incessant attacks on his constituents from May to date which he said have claimed hundreds of innocent lives without provocation.


Hon. Timothy Dantong said seven persons were killed on Tuesday night in Samba Village of Riyom Local government of the state.

"I want to confirm to you that seven persons were last night killed in Samba village in my constituency this evil act has continued unabated and this is sad. I am on my way now for the mass burial. the security agencies must take seriously the responsibility of protecting and safeguarding the lives of innocents in this state."

New Telegraph learnt that the incident occurred in the late night of Tuesday when residents had gone to bed and the attackers stormed their communities, burning some in their hon les as well as setting their properties ablaze.

The COCIN RCC Church in Bwai which is along the Mangu-Bokkos road was also burned along with houses, vehicles and tricycles. People in the Chisu community heard continuous gunshots and ran to the residence of their community leader, unfortunately the house was also set on fire, and 11 burnt bodies were picked up this morning while the search is still ongoing.

However, the State Police Command did not confirm the incident as the Police Spokesman, DSP Alfred Alabo did not pick up his call at the time of the report.
