14 Feared Dead in Enugu Communal Crisis

To fewer than 14 people were feared dead, and six houses burnt down following communal crisis which erupted at Mgbowo, a community in Awgu Local Governament of Enugu State.

Eye witness account said over 15 people were injured and have been receiving treatment in some hospitals in Enugu State.

Our Correspondent was informed that the crisis started on Saturday following the alleged shooting of six youths from the Awgu community who were said to have protested the interference of security operatives in the community's annual new yarn festival, known as "iri ji" in Igbo.

The youths were said to have alleged that the policemen were invited by some people in the community on the apprehension that the festival might be used as a political forum by some politicians in Awgu.

Our source disclosed that the Police had arrived the community with armoured vehilce and were smashing canopies and seats arranged for the festival when the aggrieved youths protested over the development.

It was gathered that the youths in their protest had six of them shot dead, and several others injured near Mgbowo Boys

Secondary School by the policemen, the venue of the cultural festival.

Our sources said angered by the killing of their colleagues, the youths rose in massive protests in the community to retaliate the action of the Police.

It was gathered that the youths in their vengeance went after some prominent indigenes who invited the police, burning over six houses belonging to them and their relations.

The crisis which started on Saturday was said to have lasted till Monday when the Enugu Police Commissioner Commissioner, Mr. Charles Dawodu, visited Awgu, apparently to assess the situation and restore normalcy.

Our Correspondent who visited Awgu on Tuesday noticed that the people of the town were yet to recover from the shock arising

from the incident. An indigene of the town who spoke to THISDAY under anonymity said among the reasons for the violence was the appointment of two traditional rulers in the town who were said to be unpopular among the peoThe traditional rulers, known

as Igwes were said to have been appointed as a result of the creation of two autonomous communities by the Enugu State Government.

It was gathered that the two houses belonging to the traditional raillers were burnt down by the angry youths to retaliate the killing of their colleagues.

The youths are accusing the traditional rullers of being behind
