In unidentified expatriate said to be an oil worker kidnapped by militants in Bayelsa State has died in Yenagoa following a protracted illness while in the custody of his abductors in the jungle. Although the name and nationality of the man could not be ascertained as at

lowing the illness of the man, the militants who kidnapped him decided to release him. It was in the process of bringing him to Yenagoa for release that the man died on the way.

Confirming the incident, the State Police Public Relations Officer, Iniobong Ibokette said one expatriate reportedly died on Sunday, but added that he was not kidnapped in Bayelsa.

He said that it was one of the incidents that happened in a neighbouring state. He however disclosed that his remains has been deposited at the Federal Medical Centre, Yenagoa.

The PPRO stated that the Police Authority is still trying to get to the root of the matter.

Even though nobody has claimed responsibility for they abduction of the man, it would be recalled that a militant group three weeks ago claimed they had kidnapped two expatriates, a claim that could not be confirmed by security operatives.

The militant group, apparently in a bid to extort ransom from the employers of the expatriates and the government raised alarm over the deteriorating health of the two expatriates. As at press time, the fate of the second expatriate remained unknown.

The two were allegedly kidnapped at Alabeni community, Ekeremor Local Government Area of Bayelsa state but nobody has bothered to look for them nor demands made to their supposed employers heeded. The militants group, 'The

Authentic Emancipation of the Movement for Peace and Development in the Niger Delta' (EMOPEND) which claimed responsibility for the kidnap through a statement in Yenagoa signed by its spokesman, Commander Jerry Sea-Lion had vowed not to release the hostages until their demands were met by the Federal and state government, as well as the oil firms operating in the area.

The threat by the group sounded strange to security operatives in Yenagoa as they claimed that they were unaware of any such kidnap that week.

The group said the hostages, a Bulgarian and a Scot were kid-napped aboard a sea going vessel called 'Monipo' which was reportedly hired by the company before it was intercepted by the armed youths who came in four speed boats.

The group said the operation in which the men were abducted was an easy one as they arrived and shot sporadically into the air, before whisking the two expatriates off to an unknown destination.

The group maintained that the hostages whose health were deteriorating, due to the non availability of medical attention and health facilities would not be released until their demands were met, with a clear agenda to develop the much exploited people of Alabeni saying "the hostages are still cooling their heels with us."
