# **Probes Ondo Accounts**

till grappling with the stoppage of over N8billion conracts it awarded, by the Economic and Financial Crimes Commission (EFCC), Independent Corrupt Practices and other related offences Commission (ICPC), has placed the financial activities of Ondo State government since 2003 under another round of scrutiny

But unlike the EFCC, ICPC went further in its probe by extending its searchlight to local government councils by requesting for details of all capital projects embarked upon by all the 18 local government councils in the state from 2003 to date.

ICPC, in its letter with Reference Number: ICPC/INV/MIN/T.Y/18 addressed to Commissioner for Finance and referred to the Accountant General of the State, Mrs Folake Ogunnika and titled: Investigation activi-Request Information/Documents, said it was investigating a case of an alleged violation of provisions of the ICPC Acts No 5 of 2000, against some civil/public servants in Ondo State.

Signed by its Head of Department (HOD) Investigation, Mr Sotonye L. Wakama, a Deputy Commissioner of Police (DCP), the anticorruption agency ordered the state government to provide

details of all capital projects in all the 18 local governments from 2003 to date.

The Commission also directed the Accountant General to furnish it with a list of all Development Millennium Goals Projects embarked upon by the state government within the same period.

It also sought to know who gave the state government the authority to deposit the state government finances/funds in interest yielding accounts as well as the exact amounts deposited in all such interest yielding accounts from May 2003 to date, as well as the actual amount of interest accruing

The ICPC's summon was received in the office of the Finance Commissioner on January 15, 2009.

#### Delta: Soldiers Killed 90 Persons – Maritime Workers happy soldiers from engaging in

#### **Petrodel Concludes Seismic Survey**

Petrodel Resources Limited, a Niger Delta concern, has concluded a 2D seismic survey in its Tanga licence offshore Tanzania. The survey was carried out by the Munin Explorer and was completed within 15 days. During this time, the vessel mapped 1,200kilometres in waters between Tanzania, Pemba Island and Kenya. The company will now process and interprete its results, after which it proposes to farm-down from its current 100 per cent position. In 2009, Petrodel Resources expects to carry out a further 3D seismic survey offshore Latham, and to drill one exploration well onshore Kimbiji. Both licences are also in Tanzania, East Africa. Petrodel is a privately-held exploration and production company. The company's main assets are in Tanzania, where it holds interests in three licences.

### **PDP: Court Stays Execution** of Earlier Judgment

Justice Sunday Imo of an Abia State High Court sitting in Umuahia yesterday ordered a stay of execution of the judgment he had earlier granted in favour of the former chairman of the state chapter of the Peoples Democratic Party (PDP), Chief Alfredo Awah. Justice Imo also ordered that status quo ante be maintained, adding that the Ndidi Okereke-led state executive be allowed uninterrupted access to the party secretariat. "In the interest of justice, and to ensure peace in the party camp, the execution of the judgment entered in this suit on the basis of terms of settlement is stayed pending the disposal of the applications. Suit is adjourned to February 5, 2009 for adoption of written addresses of counsel," Justice Imo said.

#### Pa Onyejepu Passes On

The first indigenous principal of Kings College, Lagos, a distinguished educationist, Mr. Robert Chukwuemeka Onyejepu is dead. Born on September 2, 1924, Onyejepu was buried on January 16, 2009 in his family homestead at Nnewi-ichi, Nnewi. Onyejepu was educated at the prestigious Government College, Umuahia and the Higher College, Yaba. While at the Higher College, Yaba, he sat and passed the intermediate Bachelor of Science Examination of University of London as an external student. It was such a great feat in those days that it earned front page headline in Zik's West African Pilot. In January, 1947, he was appointed Master Grade III and posted to King's College, Lagos where he taught till 1949 when he won another government scholarship to the then University College, Ibadan.
