Police Orderly Killed, Senatorial Candidate Kidnapped

The candidate of People's Progressive Party (PPP) for Anambra South senatorial district in the April 2, 2011 National Assembly election, Chief Adolphus Omenife Izuegbu, was Tuesday, kidnapped at about 7pm at Ozubulu in the Ekwusigo council area of the state.

This came as one person was reportedly killed at South Ibie town in Estako West local government of Edo State over disagreement in the sharing of money allegedly given to them by an aspirant to the House of Representatives, Mr. Abbas Bráimah.

Braimoh however denied arming the youths for the purpose of assisting him in the election saying the Estako people

were solidly behind him. Izuegbu was said to be returning from a campaign tour of communities in the council area when

could be reached," he said. Police Public Relations Officer in Anambra State, Mr. Emeka Chukwuemeka, confirmed the incident to THIS DAY vesterday but expressed regrets that the force lost an officer in the process.

He nonetheless said the state command was not aware of the N150m ransom being demanded by the hoodlums, adding however that the police had deployed more men and officers to Ekwusigo council area and Ozubulu community in particular, even as investigation into the matter had commenced. In Abia state, two voung men were reportedly killed on Tuesday and many others injured at Okom Ohafia in Ohafia Local Government Area of the state following a politically motivated clash between rival youths in the area.

While the actual cause of the

incident has become a controversial issue, eve witnesses said that gun shots were fired and one person died on the spot while the second victim, who was taken to a hospital, gave up the ghost later in the night. It was gathered that the deceased hailed from Okom and Amaekpu villages of Ohafia.

respectively. Expectedly the incident has sparked recriminations between the ruling Peoples Democratic Party (PDP) and the main opposition Progressive Peoples Alliance (PPA), each blaming the other for the killings.

Meanwhile. Governor Theodore Orii in a statement signed by his Chief Press Secretary, Kingsley Emereuwa, has commiserated with the PDP Chairman in Ohafia. Hon Kingsley Imaga, the family of the deceased and the entire Okon Aku community for the dastardly act, assuring them that Government will do everything possible to bring the perpetrators of the act to book.
