MILITANTS in the Niger Delta appear set for a show down with the police in Rivers State over the killing of some persons they termed innocent Ijaw youths.

tioned three Ijaw and Niger Delta people be handed over to the Joint Revolutionary Council (JRC)'s People's Tribunal for civilized and humane trial for the murder of the said Ijaw people as we do not have faith in the fascist Nigerian judiciary to provide an equitable and humane trial.

Failure on the part of the Nigerian state to hand over these wanted men to us within the stipulated 48 hours will result in a declaration of "120 hours of rage" against every representation and semblance of the police force.

"After a trial in absentia, we will get them wherever they may be hiding even if it be in Aso Rock Villa. Let us also warn beforehand that any one who stands between us and our cause to get justice for these innocent liaws whose lives were cut short in their prime will have himself to blame. ## Obi extends curfew by one week in Onitsha

THE joint military/police security operatives deployed to quell the crisis in Onitsha yesterday swooped on motor parks in Nnewi, Ekwulobia and Igbo-ukwu, and dislodged members of Nigeria Association of Road Transport Owners (NARTO) who have relocated their siege on these parks. The operation was ordered by Governor Peter Obi of Anambra State as part of his systamed effort to sack hood luns from the motor parks and markets in the state, even as the dusk to

dawn curfew has been extended by one week.

Also, Governor Peter Obi has said that he had not petitioned the **Economic and Financial Crimes** Commission (EFCC) to investigate the activities of his predecessor, Dr. Chris Ngige. Obi also said that the state government or any of its agencies have not been mandated to write the commission requesting it to probe Ngige. Obi who spoke to reporters yesterday in Awka shortly after making his third statewide broadcast within ten days on the Onitsha crisis, did not however rule out blackmail on the EFCC issue.
