Police allegedly beat motorcyclist to death over N20

TX/ARRI—A POLICE **VV** patrol team: vesterday, beat to death a commercial motorcyclist popularly called okada over alleged refusal to part with a N20 bribe even as other irate cyclists and concerned sympathizers beat two of the policemen to a state of coma and burnt their patrol vehicle said to belong to a member of the team.

The fracas which occurred at about 3:30pm between the upper Erejuwal/Eboh road iunction in Warri caused pandemonium in parts of the oil city that lasted several hours while commercial activities was brought to a stand still for the whole day.

Vanguard gathered that trouble started when the deceased whose identity could not be ascertained was flagged down for checking and his particulars found to be correct, yet the police

which the late cyclist refused to offer. It was at this stage argument ensued that led to the massive beating and alleged pounding of the deceased with gun butts that resulted in his death.

Evewitness account told Vanguard at the scene that it was when the police discovered that the man had died and were trying to bolt away that

aggrieved cyclists and concerned citizens pounced on them and left one in coma and another seriously injured while the police patrol car, a Peugeot, was burnt beyond recognition as others police men escaped on foot.

When Vanguard visited the Police "A" Division in Warri for comment the DPO, Mr Okoro Chris was said to have gone to the scene but a senior police officer told Vanguard that robbers were operating in the area and they got a distress call which made them sent their foot patrol team to condone off the

According to him, it was reported that the machine rider jumped from his bike on sighting the police, stressing that "there is no sign of brutality on the deceased".
