## One feared dead, five injured in youths'rampage

WKA—AT least one person has been confirmed dead and five others, including policemen wounded when Osile youths in Ogbunike town of Oyi Local Government Area went on rampage, burning and maiming some leaders of the village.

Also, seven houses belonging to some prominent indigenes of Osile were said to have been burnt by the youths who struck last weekend. Three other persons were also said to have been kidnapped by the youths.

the traditional ruler of the town, Igwe John Umenyiora of instigating the youths to cause trouble in the community. The bone of contention is the large expanse of communal land which the village is now trying to develop for the good of the villagers.

As the crisis raged, Osile Welfare League, the umbrella union of the village, has called on Governor Peter Obito impose a dusk-to-dawn cufew in the village. They have also called on the Government to set up a Judicial Commission of Inquiry to establish the remote and immediate causes of the crisis and to trace the root of the problem between the community and Igwe John Umenyiora.

The community has also implored the Government and the state police command to safeguard life and property particularly, NAUOSIL Properies Investment Company Ltd, jointly owned by Nnamdi Azikiwe University, Awka and Osile community.

In two separate petitions dated February 18, and signed by Mr. Uche Okoye, E.C.N. Okakpu, Mr. Uchebuobi Okoye and Mr. Ikwuka Ibemesi, the community blamed the crisis on Umenyiora.

They traced the in 1977, petition, how in Umenyiora applied and Osile village community agreed to lease 30 acres of its communal land to him with an agreement to develop them within five years payment of N500.00 yearly for 99 years as leasehold. But things took a different dimension when instead of the 30 acres, Umunyiora allegedly "illegally surveyed and registered with the Register of deeds at Enugu, now at Awka 45.836 hectres of Osile village land which is' equal to 113.38 acres of land".
