3 shot dead in Uyo mayhem

Continues from Page 1 ill-tempered premier league game in Uvo.

The match between Akwa United and Envimba of Aba also left many innocent traders sulking over their losses and personal injuries after the chaos spread to the streets of Uvo.

And in Aba, Efik and Ibibio natives were said to be sleeping with one eye closed as they feared reprisal attacks from Envimba supporters who returned in to narrate their escape from Uyo. But Envimba Chairman, Mr Felix Anyansi Agwu, said yesterday that he had appealed to the fans not to take the law into their hands.

In a swift reaction, a rather horrified Nigeria Football League (NFL) wielded the big stick banishing Akwa United to Minna for all their remaining matches while a three-man committee was set up to investigate the remote and immediate causes of the mayhem.

Last night, Envimba chairman, Mr Anyansi-Agwu speaking to Vanguard on phone said: "There is serious trouble now in Uyo. It is very. very serious and as I am talking to you, many lives may have been lost."

Darlington Azubuike, national co-ordinator of the twotime African champions said he was holed up in a police station with the entire contingent of the Envimba team

His words: "As I am talking to you, I don't know the whereabouts of two of our players—Uga Opara and Chidi Okeke. They are nowhere to be found. I also do not know where the chairman of our Supporters' Club is. Our luxury bus, which conveys players and officials, is damaged. Five of our vehicles have been burnt.

"At least five vehicles belonging to the Akwa Ibom State Police have been vandalised. I have never seen this kind of carnage in all my years in football. But I must commend the efforts of the Akwa Ibom State Police for their role in shielding us and leading us to their station after the match was abandoned.

"It was too much. They started coming at us with knives, shovels and other dangerous weapons. All because of a football match? I can't believe it."

It was learnt that trouble started when Envimba's striker, Ejike Uzoenyi, fired a rifle of a shot into the net but the ball was handled on its way by an Akwa United defender, leaving FIFA-badged referee Felicia Okwugba with no choice but to signal for a penalty kick. The score-line at that time, 15 minutes to go, was still 2-1 in favour of the host team.

Enyimba won the first match 3-0 in Aba. "Having scored two goals following our opening goal by Uga Opara, the Akwa United boys and fans thought they had won the match, and the fans went on the rampage when we were awarded a legitimate penalty kick," Azubuike

But Akwa Ibom State Sports Commissioner and chairman of Akwa United FC, Dr Chris Ekong blamed it all on referee Okwugba who awarded an undeserved pen-

"In the 93rd minute of the match (three minutes into added time), the referee awarded an undeserved

penalty to Enyimba FC. Even while Akwa United team accepted in good faith and wanted to play, fans were very angry and worried with the unjust actions of the referee, whom they had earlier insinuated was on the payroll of Enyimba FC. "At this point, I told the AC

(OPS), Police to move in the Police to control any situation that might arise especially on the pitch, but the response was very untimely and even lacking. It was during the melee that fans got wind of the information that the Mobile Policemen that came with Envimba FC from Abia State had shot and killed three people from the neighbouring community that came to watch the match. This news caused an uproar among fans who started attacking the referee, Police, players and officials of both teams. It was in the process that the centre referee and assistant referee (1) were assaulted, but I quickly intervened and rushed them to the hospital, while making sure

that Enyimba players were well protected.

"I was in company of the Match Commissioner, Mr. Charles Ojugbana; Mr. Davidson Owumi; Akwa Ibom State FA Chairman, Chief Effiong Johnson; and an SSS operative attached to the referee. Before we left for the hospital at about 9 p.m, I advised the Police to remove the corpse that was lying in the Stadium to the mortuary to avoid any problem when people came in the morning to see it.

"The Police promised to do that in the night, but did not remove the corpse until the community from where the dead fans came from invaded the Stadium in the morning to pick up the body. This angered them and they took a spontaneous action to go to the Police Station and deposit the corpses. Miscreants and enemies of government then joined to add ugly colour to the situation by destroying people's property," Dr Ekong explained last night.
