Double tragedy in Lagos

T was double tragedy in Lagos yesterday: Five persons were killed in an auto accident caused by fuel scarcity while many were trapped in a collapsed building.

The auto accident happened in Alapere area of the metropolis when a truck rammed into vehicles on queue for fuel, kiling the five persons and leaving scores of others seriously injured

The incident involving the collapsed building reportedly occurred at 1 p.m. at 33 Egerton Street, in Oke Arin area of central Lagos.

The debris of the three-storey building was believed to still have many people trapped under it at press time.

Governor Babatunde Fasola, who visited the scene of the incident, ordered immediate deployment of earth moving equipment to the site to help in rescue operation.

Fasola, who cut short his other engagements to visit the site, said he started making contacts with experts and organizations with equipment to assist with rescue operations as soon as reports of the incident got to him. He noted that the narrow streets and general inaccessibility to the site made rescue operation difficult insisting however that no stone would be left unturned to ensure that help reached those said to be trapped within the shortest time possible.

He said medical personnel including doctors, nurses and officials of the Lagos State Ambulance Services (LASAMBUS), Red Cross and other volunteer groups were already on hand to offer assistance.

An assistant superintendent of police (ASP) attached to Elere Division whose identity could not be immediately ascertained, his wife and cousin were said to be among those that lost their lives in the auto accident.

The fate of seven other victims, one of them the deceased ASP's daughter, were as at press time not ascertained as they were said to be in critical situation in two undisclosed private hospitals around the

area.

Eye witnesses told Sunday Vanguard that the truck apparently suffered break failure and in the driver's bid to control it, it veered off its lane and crashed into the vehicles on queue at the entrance of a filling station, waiting to buy fuel. In a further attempt to bring the truck to a

halt, it reportedly forced the vehicle in which the police officer and members of his family were sitting into a valley by China village. The truck then fell on the vehicle in the valley, making efforts to rescue the victims difficult.

The incident caused a stam-

pede as motorists reportedly abandoned their vehicles at the fuel station and took to their heels leaving the injured to their fate. Sympathisers later thronged the scene to help the critically injured to the hospital and take the bodies of the dead to mortuary. The sympathisers blamed the accident on the ongoing strike by oil marketers and truck owners which triggered fuel scarcity in Lagos metropolis.

Contacted, the Lagos State Police Public Relations Officer, Mr Olubode Ojajuni, confirmed both incidents and said police men under whose jurisdiction the incidents occurred were at the scene to provide necessary
