## Nine persons feared dead as gunboat, passenger boat collide

-TRAGEDY ZENAGOA-I struck yesterday in Bayelsa State as no fewer than nine persons were feared dead when a naval gunboat rammed into a passenger boat at the Yenagoa water front

at the Yenagoa wall (Nun River).

However four corpses including that of a child have been recovered and deposited at the Federal Medical Centre, Yenagoa which was besieged by terrified residents of the capital city as news of the tragic incident filtered into town.

was gathered that the

Naval boat was escorting a house boat belonging to one of the oil companies to an undisclosed location when it rammed head on into the Yamaha 40 horsepower pas-senger fiber boat with 14 per-

senger fiber boat with 14 persons on board.

The driver of the ill-fated passenger boat, Mr. Ataribo Memeni who spoke to Vanguard at the Federal Medical Centre (FMC) Yenagoa at about 7.45pm said he was leaving Venegoe for Fempheron. ing Yenagoa for Famgbe, opposite Yenagoa when the tragic incident occurred.
Famgbe is a stone-throw

from the capital city but could only be accessed by boat.
A shocked Memeni said he

was taken aback when the naval gunboat negotiated the sharp bend on high speed and rammed into his boat in broad

day light at about 4pm.

He said five persons survived, while four bodies including that of a child have been recovered from the river and deposited at the FMC, nagoa.

Five others are yet to be re-covered as at the time of fil-

ing this report.

One Inesai Enimasomp who works with the National Directorate of Employment also told Vanguard at the FMC that his father, Chief J.C. Nathaniel survived the accident and is receiving treatment at the emergency ward of the hospital.

When contacted, the commander of the military joint taskforce in the Niger Delta in charge of Bayelsa State, Lt. Col. Chris Musa confirmed the incident at about 8pm.

Spokesman of the Joint Task Force in the state, Lieutenant Col Sagir Musa confirmed the development to newsmen. And he said efforts were on to secure the release of those abducted.
"Information at JTF's dis-

posal has it that the children of the former chairman of Etche Local Government Council of Rivers State were abducted this morning while going to school by yet-to-be-identified criminals.

Also confirming the incidents, Police Public Relations

Officer Ireju Barasua, Deputy Superintendent of Police said the police were aware of the kidnap of the two children and investigating the matter with a view to bringing the culprits to book."
