Four Dockworkers crushed to death at Apapa port complex

rour dockworkers were yesterday crushed to death at ENL terminals, Apapa port by a faulty crane. The victims who were identified as Yusuf Ajadi, Akin Ajuwale and Aliu Olaleye were discharging fish from a vessel Green Majestic Nassau, with the IMO number 8614039, when the accident occurred. A fourth worker was crushed by an

ambulance when irate dockworkers of the ENL Consortium went on the rampage protesting the crane accident.

The ambulance was subsequently set ablaze after which the dockworkers went violent, attacking ENL officers and properties, vandalizing office equipments and cars worth millions of naira before bringing all business activities to a halt. The scene was

littered with bloodstain.

The commissioner of police port authority (PAP) Mr. J.O. Uzuagbunam told journalists that the death, though sad, was an accident. commissioner who ensured that his men were in control of the crisis at every given point. however refrained from apportioning blames on the embattled dockworkers. saying that, he perceived their reactions from pent up anger. "This is sad, but it is an accident. As for the reaction of the dockworkers. think one should understand it is coming from anger. up happened was an accident and the dockworkers were angered by the incident". He added.

Uzuegbunam appealed to the workers to remain calm while the corpse were being removed.

However, the protesting workers accused the ENL Consortium of enslaving the dockworkers.

They claimed that ENL Consortium have no condition of service even as there were no safety equipment for work.

Contrary to the claims of the vice chairman of ENL Consortium that the workers were being paid living wages, the dockworkers said that they have never received such allowances.

The workers also claimed that they were being denied medical allowances and urged the Federal Government to revert the concession of the toprivate operators.
