Robbers kill 4 policemen, 3 others in bank raid

WERRI — NO fewer than seven persons were feared dead and several others sustained varying degrees of wounds when a gang of robbers stormed the Wetheral Road. Owerri branches of two commercial banks in broad day light yesterday.

Among those who were felled by the robbers' bullets were four policemen and three civilians, although Imo State Police Command admitted that only three policemen died during the operation.

A vet to be determined amount of money was packed in huge Ghana-must-go bags and carted away bythe rampaging armed robbers.

When Vanguard visited the two banks at about 12.30pm when the robbers left the scene, their buildings were riddled with bullets while some of their customers were equally seen discussing in very low tones, even as they

were also seen discussing the broad day robbery and castigated all the securityagencies operating in the state, for failing to face the robbers' challenge, which lasted for hours. An eye witness said the robbers, who came in two vehicles, a Jeep and bus, were clad in military and mobile police uniforms.

"The robbers cordoned off the ever busy Wetheral Road, shot indiscriminately into the bright sunny Thursday afternoon skies and within a twinkle of an eye, overran the two commercial banks and quickly commenced their nefarious operation", the badly shaken woman recounted.
