Missing councillor found dead

KANO—POLICE detectives have commenced investigations into the mysterious death of a councillor, representing Sabon-Gari and Ragada constituency in Doguwa Local Government, Malam Musa Muhammad

Muhammad left his hometown, Thursday, for Jos, Plateua State and was subsequently declared missing by the family following a break in communication.

Vanguard learnt that nothing was heard from Musa four days after he embarked on the journey until the sad news that his corpse was found in a remote village near Saminaka, Kaduna State.


The councillor was reported to have boarded a private vehicle on the ill-fated journey to Jos, and there is a strong suspicion that he might have been a victim of armed robbery.

Kano-Jos gained notoriety following persistent robbery incidents by a syndicate that specialised in hanging their victims before dispossessing them of their valuable, a situation that compelled the police authority to draft a combined team of army and the police

Confirming the incident to newsmen in Kano, Police Public Relations Officer, Baba Muhammad declared that the police is working to unravel the circumstances that led to the death of the elected council-

He stressed that the police is working on several clues that may lead to the perpetrators of the act, and urged the public to remain calm. Malam Musa's remains had since been buried in his home town according to Islamic rites.

Fresh crisis in Benue claims 3, renders 760 homeless

MAKURDI—A FRESH outbreak of communal crisis between the Nyieev and Uyougho communities of Kwande Local Government-Council of Benue State have claimed the lives of three persons while over 760 persons have been displaced and rendered homeless.

An eyewitness told Vanguard that herds of refugees from the affected villages have taken over neighbouring towns and villages bordering the feuding communities while heavy fighting continued unabated.

According to our source, the renewed fighting in the area was sparked by allegations of land trespassing traded by the warring comad ing feuding communities ac-

on disputed land which had hitherto claimed lives.

He intimated that the conflict has taken a dangerous dimension with the involvement of militia groups by both sides resulting in the use of dangerous weapons by the communities.

The renewed clash, which is about the fourth between the warring communities in recent time, has left the communities deserted with farmlands utterly destroyed by the rampaging fighters.

Our source further hinted that economic trees and huts have been torched by the fighters who are bent on establishing their authority over the disputed territory.

According to him, "At the time I fled my home to escaped with my dear life, neavy fighting was still going on and homes of some prominent indigenes of the area had already been reduced to rubbles with no end to the conflict in sight.'

Meanwhile, all attempts to reach the Kwande Local Government Council Chairman, Mr. Terlumun Akputu for his comments on the renewed crisis proved abor-

Moreover, one of his Special Assistants told Vanguard that the Chairman has embarked on moves to permanently address the crisis in the area by personally assuming the position of a mediator in the conflict.

When contacted, the Police Public Relations Officer (PPRO), DSP Samuel Jinadu informed that he was yet to get the full brief on the conflict.

Councillors exchange blows over impeachment move

L OKOJA — TWO councillors, yesterday, sustained serious injuries in Ugwolawo, headquarters of Ofu Local Government fighting broke out among the legislators over alleged moves to impeach the chairman of the council.

It would be recalled that the legislators had, last week in a unanimous resolution, served an impeachment notice to Mr. Peters Eneio seeking to remove him from office over what they described as his "woeful performance in the last two years as chief executive of the

council". The impeachment notice

signed by two third of members of the council also alleged that the chairman had failed to tell them the correct monthly allocations accruable to the council since he took over the mantle of leadership in the area.

high-handedness and abuse of office as he allegedly dips his hands into the council's purse without recourse to the legislators, allegations which he denied as baseless and unfounded.

There was, however, a twist in the crisis as some of the legislators, yesterday, opted out of the decision feigning ignorance of the alleged impeachment moves, a development that infuriated some of the legislators leading to a free-for-all.
