Generator inferno: Man, wife, 2 kids burnt to death

WARRI — TRAGEDY struck, yesterday at Ajamimogha, Warri, Delta State, when a midnight inferno allegedly caused by a generating set, consumed a 37-year-old man, his wife, a six-month-old baby girl and their three years old daughter.

The man, Mr. Nuhu Eg-bunu, an Igala from Kogi State, was said to have hosted his town union's meeting on Sunday and went to bed

late, with his generator on, until the unfortunate incident. Neighbours said the fire started at about 12 midnight.

Narrating how he narrowly escaped death, Mr. Godwin Menetie, said he was woken up by the persistent knocks on the wooden partition separating his room and that of the deceased family, who he suspected must have been choked by the carbon monoxide from the generator and were perhaps struggling with death

already.

He said when he came out and saw the fire, he had to rescue his family first while shouting for help like others, who were busy evacuating their children and belongings to safety also.

Vanguard gathered that though men from the fire service came on time, they had just little water, which could not put out the flame even with the efforts by hundreds of youths from the community. By the time the inferno subsided, two

buildings made of zinc and wood had been reduced to rubbles. The over 50 inhabitants of the buildings now quartered at the community's town hall.

When *Vanguard* visited the scene, large crowd of sympathisers were seen weeping and lamenting the death of the young couple and their two children.

Meanwhile, their charred remains had been taken back to their home state, Kogi, for proper burial by their relations.

Suspected cultists' clash leaves 4 dead

UGHELLI — FOUR persons were feared dead, yesterday, in Ozoro, Delta State, during a violent clash between members of two suspected secret cult groups.

A dependable source told *Vanguard* that a member of one of the groups was feared dead, Sunday night.

The source, who pleaded anonymity, said three other persons suspected to be members of rival groups were shot dead in a reprisal attack in the early hours of yesterday at Alah Square in

the Ozoro metropolis.

It was learnt that residents of the area had to scamper for safety for fear of being hit by stray bullets from the suspected cultists' exchange of fire.

The Alah Square area of the town, *Vanguard* gathered, had been deserted. The reason for the recent clash was still hazy at press time.

Efforts to reach the Divisional Police Officer, DPO, in charge of Ozoro Police Division, proved abortive at press time. However, a senior police officer in the division confirmed the incident.
