# Protest over alleged police brutality claims 5 in Kano

KANO—A VIOLENT protest by angry youths in Dambatta, close to Kano city, over alleged police brutality claimed no fewer than five lives as dozen others sustained serious injuries.

Eye witness accounts told Vanguard that the demonstration was triggered-off by the death of a suspected thief in police custody. Protest by the family of the decease over the death spread like wildfire in the town.

The suspected thief. whose identity was still shrouded in secrecy was said to have been apprehended by the community. and handed over to the police 'hale and hearty' at the time of the crime.

Sources said that the remains of the suspected thief was escorted by hundreds of youths to the palace of the District Head of the town before he was laid

Vanguard learnt that trouble started when the protesting youths made a spirited attempt to raze the police station in the town in retaliation but were rebuffed.

In the ensuing melee, unconfirmed reports said that five people died of gun shot wounds while dozens were equally injured in the crisis that lasted four hours in the city, 60km away from

Vanguard learnt that those with injuries were treated at the Dambatta General Hospital, while those with critical injuries were taken to private hospitals in Kano.

Normalcy had since been restored to the town following the deployment of anti riot police squad, but Vanguard noted that there was uneasy calm in the town as the streets were desolate and abandoned.

# Mother, daughter perish in petrol fire accident

SABA—FEW months Aafter the tragic collapse of an overhead tank at College of Education, Agbor, Delta State, which killed five pupils on November 2 last year, a petrol fire has claimed the lives of a 53 year old mother and her daughter in the area.

Vanguard gathered that the incident occurred weekend, when a motor cycle conveying jerry cans of fuel which was on top speed lost control and collided with another motorcycle conveying the mother and

the daughter. Report from the area said immediately the two motor-cycles collided, fire ignited and engulfed the occupants of the two motorcycles.

The woman was identi-

fied as Mrs. Blessing Igbenije while her 23 year old daughter's name was given as Izioma Igbenije. They died instantly, including the rider of the motorcycle that hit them, said to be popular seller of petrol in the black market. He was said to have been heading to Ekuku-Agbor, when the accident took place at Ogbe-Ohun, few metres to the house of the late woman, whose husband is a proiessionai taiior .

Efforts by passersby to put out the fire were unsuc-

cessful because the fire was so intensive. Reacting to the incident, the State Police Public Relations Officer, Mr. Charles Muka said "it was an unfortunate ncident. People should buy fuel from petrol stations to avoid fire.

# Female police officer robbed of N55,000

SABA-FEAR has A gripped residents of Asaba, Delta State capital, following the upsurge of robbery attacks especially snatching of money and telephone handsets from them by the armed hoodlums, who usually operate on motor cycles, popularly called Okada.

A female police officer fell victim of such attack weekend, after withdrawing the sum of N55,000 from a new generation bank.

She was trailed by a twoman gang operating on Okada and robbed of the money at gun point in Asaba in a commando manner. There were several similar cases in and around Asaba.

But the state police comspokesman, mand's Mr.Charles Muka, denied that the situation was out of control, saying that police was on top of the situation and called for information from well-meaning members of the public to fighting crime generally in

the state. Muka also said that two notorious armed robbers were gunned down in Warri. According to him, on the 15.2.11 at about 2230 hours, Quick Response Squad, QRS, in Warri received information that armed robbers were operating along Giwa Amu/ Apala Street Warri. The team rushed to the scene and engaged the robbers in a gun duel and gunned down two of the robbers while two members of the gang escaped with bullet wounds", adding that "two locally made cut to size were recovered.
