# We killed more than 10 soldiers

As Police recover bodies of five slain colleagues

WARRI-MOVE MENT for the Emancipation of the Niger Delta, MEND, yesterday, said that it was not only four military men that were killed in the March 2, gun fight between Joint Task Force, codenamed Operation Pulo Shield, with militants in the creek of Bayelsa State, adding that over 10 soldiers, including a Lieutenant Colonel, were killed.

It also said none of its men was killed in the encounter and challenged the task force to produce the corpse of any of its fighters that was killed.

Meanwhile, the Police in Bayelsa State said

Yenagoa.

Emokpai said the policemen were shot at a marine police post along Nembe waterway by unknown gunmen.

According to a family source who pleaded anonymity, when they got

there, they saw the corpse and invited the pelice to the scene before removing the deceased to Warri Central Hospital morgue.

Security account revealed that the Managing Director of the hotel, said the deceased was invited by a guest who works in Port Harcourt, Rivers State, who had lodged in the hotel on March 4. His identity was discovered through the identity card found in the bag left behind in the hotel.

It was learnt that Managing Director of the hotel disclosed that at about 11p.m., the said guest informed waiters in the hotel that Caroline, was vomiting and that he was taking her to the hospital for treatment, noting that they both did not return to the hotel.

Though no arrest had been made, Police from the "B" Division, Warri are already on the trail of the key suspect.

#### Gunmen kill Yobe, Borno Customs' Comptroller

ANO (AFP) – Un known gunmen in Nigeria late Tuesday shot dead a senior customs officer in charge of two states that have recently been rocked by Islamist attacks, police said.

Adamu Amadu, Comptroller of Nigeria Customs Service for Yobe and Borno states, was shot dead along with his bodyguard when gunmen stormed his house in the Garin Daji district of Potiskum, a major city in Yobe, said state police commissioner Lawan Tanko said.

"I have received the report of the killing of the comptroller of customs for Borno and Yobe states in his personal home in Potiskum this evening,' he said on telephone from Damaturu, capital of Yobe.

"From reports reaching me, he was shot dead by unknown gunmen along with his bodyguard. The gunmen stormed his house around 7:30 pm (1830 GMT), shot them dead and fled," he said.

He said that policemen have been mobilised to track down down the attackers. "We hope our hunt will be successful," he said. He declined to speculate on who the attackers were, saying that investigations were underway.

The neighbouring states of Borno and Yobe have in the past months witnessed a spate of gun and bomb attacks blamed on Boko Haram Islamist

The group, blamed for a wave of violence mainly in northern Nigeria, had over the past twoand-half years targeted mostly the police and other symbols of authority in Africa's most populous nation.

It has lately added churches on its list of tar-

Although its specific aims remain largely unclear, violence by the sect since mid-2009 has claimed more than 1,000 lives, including more than 300 this year alone, according to AFP and rights groups.

## Security man jailed 6yrs over murder attempt
