Youths protest over mysterious deaths in Imo

Ogwa Community, Mbaitoli
Local Government Area of Imo
State have protested against a
dead woman who they alleged
was responsible for the
untimely death of youngsters
in the area.

The youths said that the ghost of late Mrs. Latricha Mbataku Ononuju whose body had been at a hospital mortuary in Owerri, the state capital for over 10 years was responsible for the untimely death of some of them in the area.

The youths spoke in an interview with South East Voice while protesting at the Imo State police headquarters, Owerri.

The leader of the youths, Ernest Nnanna said that they were at the police headquarters to demand for the release of some of them who were detained in connection with the

issue as well as to urge the police to assist them hasten the funeral/burial ceremonies of late Madam Ononuju to save more people from perishing in their village.

Some of the placards carried by the youths read: "Police we need your intervention; "26 lives lost because of witchcraft operation," "Ononuju must be buried to stop ritual killings," "Stop the witchcraft," "Stop ritual deaths now," "Bury this woman for families to have peace and progress."

Nnanna alleged that some relations of late Ononuju, had always treated the matter with levity whenever it was to be discussed in the community, adding that no fewer than 26 of them (youths) had died as a result of the spiritual attacks by the deceased, whose ghost had been hovering around.

The youths further told South East Voice that the late woman had severally appeared in their dreams to issue warnings to the villagers that she (Latricha)

wanted her remains to be buried in order to have rest, adding that failure to do so would lead to more ugly things happening in the village.
