# Police allegedly strangle guard over missing laptop • Police killed him because of N100,000 bribe—Family

• Suspect complained of headache, rushed to the hospital and died-PPRO, Delta

SABA—POLICE
OFFICERS at 'A'
Division Police Station, Asaba,
Delta State, have allegedly
strangulated a security guard
attached to the Ministry of Oil
and Gas, Asaba, Mr.
Ogodobiri Ebifemene, over a
missing laptop at the office.

Police arrested Ebifemene, a security guard and father of four children, on November 17, and other suspects in connection with the loss of the laptop belonging to an aide to the Commissioner in charge of the Ministry, but while other suspects "played ball" and secured bail, they detained Ebifemene for three days.

#### Alleged N100,000 bribe

A relation of the deceased, Cletus Kwalekeme, told Vanguard, yesterday, that police officers at the 'A" Division demanded a N100, 000 bribe from him and refused to release his nephew on bail unless he paid the money.

He said the said police officers thwarted his attempts to meet the Divisional Police Officer, DPO, telling him that it would aggravate the matter.

Kwalekeme claimed that in order not to allow his nephew suffer needlessly in detention; he sourced for N100,000 and came to the station on November 20, three days after his arrest, but could not locate him.

According to him, "I went to

Consequently, he was brought out of the cell and rushed to the Police Hospital, Asaba for treatment and was later certified dead.

"Meanwhile, the corpse of

the deceased has been deposited at the Federal Medical Centre, FMC, Mortuary, Asaba for post mortem examination while investigation is ongoing," she added.

#### Family dismisses Police claim

The family of the deceased dismissed the claim of the PPRO and in petition dated November 20 to the Inspector

General of Police, entitle "Complaint of the unlaw killing of Mr. Ogodob Ebifemene, a suspect Police Cell- 'A' Divisio Asaba."

It called on the poli authority to investigate t matter with a view bringing the perpetrators book and avert the loomi crisis that might arise fro his premeditated murder.
